CREATING A NEW COMPREHENSIVE PLAN ELEMENT ENTITLED, "CHAPTER 10, PROPERTY RIGHTS ELEMENT", AND GOAL 10-1, OBJECTIVE 10-1.1, AND POLICIES 10-1.1.1- 10-1.1.4; PURSUANT TO 90, ARTICLE VI, DIVISION 3; PROVIDING FOR TRANSMITTAL TO THE STATE LAND PLANNING AGENCY; PROVIDING FOR THE FILING WITH SECRETARY OF STATE; PROVIDING FOR SEVERABILITY; PROVIDING FOR REPEAL INCONSISTENT PROVISIONS; PROVIDING FOR THE INCLUSION IN THE CITY OF KEY WEST COMPREHENSIVE PLAN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the State of Florida Statute 163.3177(6)(i)1. requires local governments to amend Comprehensive Plans to adopt a Property Rights Element; and

WHEREAS, this state regulation requires this new chapter/element to be approved for adoption prior to other Comprehensive Plan amendments; and

WHEREAS, by including this element the City affirms its support for the rights of all people to participate in planning decisions through transparency, predictability, and reliability; and
