On Sunday, July 18, 2021, at approximately 2135 hours, I (Ofc. N. Wynn) was dispatched to the intersection of N Roosevelt Blvd and Overseas Hwy in reference to a DUI Investigation.

Ofc. Agleev was dispatched to a Traffic Crash at this location and in the course of his investigation became concerned that the driver of the at fault vehicle was intoxicated. I serve as a Traffic Unit for Alpha Night Patrol and was requested to assist with the DUI Investigation.

I arrived and spoke with Ofc. Agleev. Ofc. Agleev said that while he was interviewing the driver of the at-fault vehicle in the crash, identified as Adam Korzen, he detected the odor of alcoholic beverage on his breath. Ofc. Agleev said that Korzen's speech was slurred and that his eyes were watery and bloodshot.

While Ofc. Agleev continued his crash investigation I spoke to the driver of the vehicle that was struck in the crash, identified as Daniel Sisson. Sisson said that Korzen had been driving the vehicle that struck him and that he saw Korzen get out of the drivers side of the vehicle and walk up to Sisson's vehicle after the crash.

I then spoke to Korzen as part of the crash investigation and he confirmed the events of the crash. When Korzen spoke with me I could smell the odor of an alcoholic beverage on his breath. Korzen's eyes were watery and bloodshot, and his speech was slurred. Korzen was also very unsteady while he stood to speak with me. I became concerned that Korzen was operating a vehicle under the influence of an intoxicant.

After the conclusion of Ofc. Agleev's crash investigation, I informed Korzen that I was going to conduct a separate DUI Investigation based on my concerns that he was operating a vehicle under the influence of an intoxicant. Informed Korzen that before I began my investigation I was going to advise him of his Miranda Rights. I read Korzen the Miranda Warning. Korzen said that he understood his rights as I explained them to him. Korzen said that he did not wish to speak to me at that time. I told Korzen that was fine and I did not ask him any for further information about the incident. I did ask Korzen if he was willing to participate in Field Sobriety Exercised to dispel my concerns that he was driving under the influence. Korzen did agree to participate in the Field Sobriety Exercises.

The FIELD SOBRIETY EXERCISE RESULTS:

1) Horizontal Gaze Nystagmus: Before performing the exercise I asked Korzen: "Are you sick or injured?", "Do you have any physical defects?", and "Are you diabetic?". Korzen answered "No" to all the questions. I asked Korzen if he wore corrective lenses, contacts, or if he was blind in either eye. Korzen said he sometimes wears contacts but did not have any in at that time. I explained the exercise to Korzen. Korzen stated that he understood the instructions. Korzen had trouble standing without weaving while I administered the exercise. I had to ask Korzen three times to keep his head still while I administered the exercise. Korzen was finally able to follow the stimulus, his eyes tracked equally, and had equal pupil size. During the exercise I observed six clues. Korzen had lack of smooth pursuit in both eyes and had distinct, sustained Nystagmus at maximum deviation on both eyes, and Onset prior to 45 degrees in the right and left eye. I observed Vertical Nystagmus when I administered the exercise to Korzen.

2) Walk and Turn: I had Korzen place his left foot on a seem between concrete slabs in the sidewalk. I then had Korzen place his right foot on the line in front of his left, with the right heel touching his left toe. I asked Korzen to put his hands down by his side while I explained the exercise. Korzen was not able to stabilize himself in that position. As I attempted to give Korzen further instructions on the exercise, he lost his balance and nearly fell. I gave

three more opportunities to stand in that position, but each time he lost his balance while I attempted to give further instructions. I stopped the exercise because I felt that Korzen would not be able to safely complete it.

3) One Leg Stand: I had Korzen stand with his feet together and his hands down by his side while I explained the exercise. Korzen said understood the instructions. Korzen began the exercise by lifting his right foot and immediately lost his balance and had to put his foot down. Korzen attempted to lift his right foot again but immediately lost his balance and nearly fell. I allowed Korzen to attempt lift his foot again, but he lost his balance and I stopped the exercise out of concern for his safety.

Based on my training and experience and the totality of circumstances; his appearance, the odor of an alcoholic beverage, and his performance of SFSE's, I believe Korzen was impaired by either an alcoholic beverage and/or chemical substance which impaired his normal faculties to safely operate a motor vehicle.

I informed Korzen that I was placing him under arrest for DUI. I placed Korzen in handcuffs, checking for proper tension and making sure they were double-locked. Korzen was searched and secured in the rear of my patrol vehicle by Ofc. Agleev.

I transported Korzen to the Monroe County Detention Center. Korzen remained in the back of my car while we waited in the sally port for Correction Deputies to take Korzen to intake. After several minutes Korzen slammed his head against the plexiglass separator in the back of my patrol vehicle. I open the rear door of my vehicle and asked him what was wrong. Korzen was breathing heavy and said "air". I point out to Korzen all the places that air entered the rear compartment of my patrol vehicle. I told Korzen to stop pretending like he was suffocating to try and get out of his arrest. I left the door to the vehicle open while we continued to wait for Correction Deputies. Korzen then kept telling me to close the door. Deputies arrived and took Korzen's temperature I put a mask on Korzen and asked him to step out of the vehicle. Korzen at first pretended to be unresponsive and unconscious. I told Korzen I was going to give him a hand and I took Korzen's right leg out of the vehicle and placed his foot on the floor and asked him to stand up and get out of the vehicle. Korzen again pretended to be unconscious. Korzen refused to move so I took him under the right shoulder and dragged him out of my vehicle and laid him on the floor of the sally port. Korzen had hooked his left foot under the partition in my vehicle so I unhooked it so the he had both legs free. I asked Korzen if he would like to stop acting up and get himself up. Korzen then complained about his leg. A Corrections Deputy and I attempted to stand Korzen up but he just went limp so that he became dead weight. At that point we laid Korzen on his left side. I asked Korzen to what he wanted me to do. Korzen refused to answer and then said "Hospital". I explained to Korzen that I was not going to take him to the hospital, but I was going to add the charge of resisting to his arrest. I sat Korzen up and he refused to get up. Korzen complained that I left him in the car of thirty minutes. I explained to Korzen that I was also in the car during that time, and that there was air flowing into the back of the car, and that I could feel the air in the back of the vehicle as we were still sitting in the doorway of my patrol car. I was supporting Korzen in a seated position and attempted again to get him up from under his arms. The Corrections Deputy assisted, but Korzen went "dead weight" again. I stepped back and the Corrections Deputy laid Korzen in the recovery position on his right side. I asked the Corrections Deputy to just get the chair to transport him upstairs to intake. Korzen said "you want to grab the chair?" and started slamming his head onto the concrete floor of the sally port. I moved in behind Korzen and held his head so he could not longer slam it into the floor. Deputies went to get the chair while I remained and restrained Korzen to prevent him from hurting himself. I again asked Korzen if he wanted to stop acting up, and he responded "no". Korzen finally relaxed and allowed me to put him in a more comfortable position. I left my hand underneath his head to protect it. I asked Korzen if he wanted me to sit him up and he said yes. I helped Korzen into a seated position and let him rest again my leg. When Deputies

returned I with the chair I told them that it wouldn't be needed, and Korzen was escorted to intake under his own power. I asked Deputies to hold Korzen in the DUI Room. I contacted Sgt. Sims to explain the situation.

When I arrived upstairs in the DUI Room Korzen had again become agitated. Korzen was complaining about the tightness of his handcuffs that that he could not feel his fingers. I explained to Korzen that I would loosen the handcuffs while we waited for the Intoxilyzer if he would calm down. Korzen remained agitated. I tried to calm him and told him if he would turn around I would loosen the handcuffs. Korzen instead dropped his head and tried to run at the door across the room, again to potentially injure himself and go to the hospital. I tackled Korzen before he reached to wall. I left Korzen on the floor asked Korzen if he was willing to take the Breath Test. Korzen didn't answer so I asked him again two more times. He still refused to answer so I read Korzen the Implied Consent Warning. At the end of the Implied Consent Warning I asked him if he understood. Korzen said he was a Polish citizen and wanted to speak to someone at his embassy. I explained that, Polish or not, he had agreed to Implied Consent when he decided to get a Driver License in the State of Florida. I asked two more times if he understood the Implied Consent Warning. Both times he said that he was a Polish citizen and wanted to speak to someone at his embassy. I took his comments and refusal to answer the question as a refusal for the Breath Test. Korzen also refused to sign his DUI citation.

BREATH TEST RESULTS: BREATH TEST REFUSED

I requested that Deputies go ahead and process Korzen. During Korzen's initial medical examination the nurse refused his admission to the Monroe County Detention Center due to the bumps on his head, which he had caused himself on the sally port floor, and requested medical clearance from Lower Keys Medical Center.

Deputies assisted me in taking Korzen back to my patrol vehicle. I placed Korzen back in handcuffs, checking to make sure that they were at the proper tension and that they were double-locked. I opened my vehicle door and turned Korzen around so that he could sit in. Korzen looked at me and reared his head forward in an attempt to slam it back into the frame of my vehicle door. I stepped in and grabbed Korzen's head before head could slam it back and I pushed Korzen into my vehicle. I got him seated and secured. Korzen kept trying to put his knee in the way of the door. I went to close the vehicle door and he pushed against it with his knee. I was finally able to get the door closed. I informed Key West Communications that I was transporting Korzen to Lower Keys Medical Center. I requested security meet me outside. I requested that Sgt. Sims or Sgt. Rodriguez meet me at Lower Keys Medical Center.

I arrived at Lower Keys Medical Center and was met by security. Ofc. Hudson was already at the hospital on another call and assisted me. We escorted Korzen into an examination room in the Emergency Room. Sgt. Sims arrived and interviewed Korzen. Korzen informed Sgt. Sims that he wanted to log a formal complaint about me, stating my lack of professionalism, my conduct unbecoming of an officer, and excessive use of force. Korzen continued to complain about his handcuffs. The attending ER physician Dr. Alvarez came examined Korzen. Finding nothing wrong with Korzen Dr. Alvarez signed his medical release for immediate return to Monroe County Detention Center.

After Dr. Alvarez signed the medical release Sgt. Sims and I informed Korzen that he was being taken back to jail. Korzen immediately pretended to be unconscious again, closing his eyes and letting his body go limp. Korzen's head was drooping off the bed and it appeared as if he was attempting to slide off. Sgt. Sims and I had to hold him up on

the bed to prevent him from sliding off. Sgt. Sims used an ammonia capsule to revive Korzen, who would immediately become alert when he inhaled the ammonia, but would again pretend to fall into unconsciousness as soon as the air cleared.

I was eventually able to get Korzen into a seated position on the hospital bed. From the seated position I was able to pull Korzen up to his feet. Korzen again attempted to go limp and become "dead weight", however Sgt. Sims and I were about to hook under his arms and hold him up. Sgt Sims and I had to drag Korzen through the Emergency Room to get to my patrol vehicle, and Korzen would shift his weight in an attempt to make us lose our balance, and causing me to bump into the administrative desk. One of the hospital security guards picked up Korzen's feet, and we were able to successfully navigate the rest of the ER and get Korzen to my patrol vehicle. At my vehicle Korzen stood up on his own feet. I instructed Korzen to get in my vehicle but he was in a front-facing position and had to be turned around. Once Korzen was positioned so that he could sit into my vehicle, he still refused to get in I grabbed Korzen's head to protect it and pushed Korzen's hips into a seated position in my vehicle with his legs still outside. I instructed Korzen to put his legs in the vehicle and refused. Sgt. Sims instructed Korzen to put his legs into the vehicle and he refused. Sgt. Sims unholstered his taser and removed the cartridge. Sgt. Sims informed Korzen that he was going to give him to the count of three to get in the vehicle or he would tase him. Sgt. Sims counted to three and Korzen did not comply. Sgt. Sims then cartridge-off drive stunned Korzen and Korzen put his legs in the vehicle.

Korzen was again transported to the Monroe County Detention Center. Sgt. A. Rodriguez met me and Sgt. Sims at the detention center sally port. Sgt. A. Rodriguez interviewed Korzen and took pictures of the marks from the tasing. Corrections Deputies met me at my vehicle with the restraining chair. Korzen was transferred to the chair and secured, and taken up to intake without incident.

Korzen received the following citations:

UNIFORM DUI CITATION number A0LKP6E: F.S.S. 316.193-3C1(374)(T) DUI and Damaged Property

UNIFORM TRAFFIC CITATION number AEU4V9E: Refusal to Accept and Sign Citation

Korzen was assigned a Court date of 07/30/2021 with Judge Wilson, 9:00 am, at the Key West Courthouse in reference to the DUI charge.

For further information about the DUI case, please see the completed DUI packet. This incident was recorded on my BWC.

ADDITIONAL PROBABLE CAUSE STATEMENT

Adam Korzen made multiple attempts to resist my efforts to take him from my patrol vehicle to the intake area of the Monroe County Detention Center. Korzen faked being unconscious. Korzen went limp and refused to stand on his own when I attempted to get him out of my vehicle. I had to pull Korzen out of my vehicle and place him on the floor the sally port of the Monroe County Detention Center. When a Correction Deputy and I told Korzen that we were going to place him in the restraining chair, Korzen began to slam his own head on the concrete. I had to physically restrain Korzen from slamming his head on the floor. Korzen's self-inflicted head injury caused the detention center to request medical clearance, and Korzen then had to be transported to the Lower Keys Medical Center. Once cleared by the attending physician at the Emergency Room, Korzen immediately pretended to be unconscious again, and had to be dragged by Sgt. Sims, hospital security, and me to my patrol vehicle. Korzen

refused to get into my patrol vehicle and had to be pushed into a seated position. Korzen still had his legs outside of my vehicle and refused to put them in. Sgt. Sims deployed his taser and Korzen was warned multiple times that he would be tased if Korzen did not comply. Korzen continued to refuse to comply with Sgt. Sims' and my instruction. Sgt. Sims performed a cartridge-off drive stun with his taser, and Korzen complied. Officer involved were wearing Key West Police Department Class-B uniforms and arrived in my vehicles marked with Key West Police Department emblems and colors. I was legally authorized to arrest Korzen for DUI and transport him to the Monroe County Detention Center. Korzen knew and understood that I was legally authorized to take him into custody. Based on these factors I had probable cause to charge Korzen for violation of F.S.S. 843.02, RESISTING AN OFFICER WITHOUT VIOLENCE.

On 07.19.21 at approximately 2300 hours, I, Sgt. Carter Sims, responded to the Lower Keys Medical Center Emergency Room. I did this to meet with Ofc. Craig Wynn, who was there with an arrested subject, Adam Korzen 08.13.78. Korzen had been taken to the jail but was refused by the medical staff for a bump on his forehead. However, prior to this I had responded to the area of 2900 Harris Ave. I was going to pick up a bicycle for Ofc. Juan Soza, using the spare KYPD pickup truck. I had just put my BWC in the docking station to download and left it at the station, not knowing I was going to end up at the hospital.

At the ER, I met with Ofc. Wynn and Adam in one of the rooms. Adam was handcuffed behind his back and laying on his back at the same time. I could hear Adam complaining about the handcuffs being too tight, with Ofc. Wynn explaining to him that they were properly applied and double locked. During this time Adam was moving his hands back and forth saying it hurt and that the hands were tingling. In an over abundance of caution, I checked them and found them to be applied properly according to training. It should be noted I am a certified Defensive Tactics Instructor with the Florida Department of Law Enforcement and have been since 2005. However, I still loosened the right handcuff in a valid attempt to provide some level of comfort for Adam. This attempt was futile as he still complained, laid on his back, and twisted his hands in the handcuffs.

Adam went on to complain that Ofc. Wynn was unprofessional and an officer unbecoming. He was never clear on exactly what was said or done but did say Ofc. Wynn was excessive when he placed him in the backseat of the car. Adam said that he wanted to make a complaint and that he would follow up on said complaint when he got out of prison. Curious, I asked why he was going to prison. Adam said he was on probation for a battery charge (said he beat up his girlfriend). I forgot to mention, I have had several law enforcement contacts with Adam, and know him not to be an upstanding citizen. He has a history of narcotics violations, hit, and run, and DUI.

Dr. Alvarez the attending ER physician came in to speak with Adam and treat the bumps on his head. He complained to her about the handcuffs. Dr. Alvarez told Adam the handcuffs were probably pushing against the nerves in his wrist which may be causing the tingling sensation. Dr. Alvarez explained to him that when he repositioned himself, he should get some relief.

After Dr. Alvarez walked out of the room Ofc. Wynn and I explained to Adam that he needed to sit up so we could get ready to take him to jail. Adam played 'dead' by closing his eyes, letting his head droop off the bed, then obviously moving his legs to the edge of the bed, to let one of them fall off. Ofc. Wynn and I had to physically hold him up to prevent him from falling. This pattern of behavior continued for a minute or two, with Adam (acting as if he was passed out), actively pushing/pulling against us in a mild manner, still trying to throw himself to the ground.

I thought using an ammonia capsule would help Adam come around and 'wake up'. This took a bit because he tried to fight the odor of the ammonia. He would move about back and forth, then 'fall asleep' again. Eventually Ofc. Wynn was able to get him into a seated position and in turn used the momentum to stand Adam up. Adam tried to drop his body weight to the ground but Ofc. Wynn and I were able to use 'underhooks' (placing our arms under Adam's arms and bringing our hands back over to the top of his shoulders).

From here we had to get him out of the ER and into the car. This proved to be more difficult than expected. Again, in a

frivolous attempt to defeat our control Adam dropped his body weight as we walked thru the ER. This action caused Ofc. Wynn and I to essentially ping pong off a couple of walls, counter, and medical equipment. As we neared the exit door, I saw the security guard running up behind us. The security guard picked up Adam's feet and helped carry him to the car. I do not have his reporting information.

At the car Adam was placed against the trunk area while I opened the door. By now, he was standing upright, making him easier to move. I got the door open and we tried to put Adam in the backseat. First Adam tried to get in headfirst, then we stopped him and turned him around. Ofc. Wynn had to physically push him back to get him into a seated position. He did this by placing a hand behind Adam's head and pulling it forward so he would not hit it on the door jamb. Then another hand near his torso. Adam sat and looked at me saying, "did you see that excessiveness?" I do not remember my reply, but am pretty sure it was, "YES!" Now, several times we told Adam to get in the car, as he was refusing to put his feet in.

I told Adam, in no uncertain terms, that I would TASER him, if he did not get in. Adam kept talking about the excessiveness. I unholstered my TASER removed the cartridge and armed it. I told Adam I was going to count to three and TASE him if he did not put his legs and feet in the car. I counted down and Adam had not moved. With some degree of force, I pressed the TASER against Adam's stomach as I pulled the trigger, holding it down, and using it to push him into the car. The length of time was approximate to two cycles (ten seconds). Adam put his feet and legs in the car. I aired this information on COMM1 to notify Sgt. Alex Rodriguez.

Adam displayed the following type of subject resistance:

Passive Resistance A person verbally and/or physically refuses to comply or respond to the officer's requests or attempts to control the situation. The subject does not make any attempt to physically defeat the actions of the officer but forces the officer to employ physical maneuvers to establish control.

Adam did this by playing 'dead' in the hospital room and refusing to get up. He caused Ofc. Wynn and I to have to physically hold him up.

Active Resistance A person makes physically evasive movements to defeat an officer's attempts at control.

Adam did this by continually dropping his body weight to the ground as we tried to walk him to the car. This action caused us to ping pong off items in the ER. At the car, Adam refused to put his legs and feet in the back.

I responded to Adam's resistance by the following:

Physical Control Achieving compliance or custody through the use of empty-hand or leverage-enhanced techniques, such as restraint devices, transporters, take-downs, pain compliance and countermoves.

4. Pain Compliance - Techniques that force a person to comply with an officer as a result of the officer inflicting controlled pain upon specific points on the person's body, such as pressure point techniques or the use of a TASER® device for passive resistance in the drive- stun only mode.

I had the option to use the TASER with the cartridge on because of his active resistance. However, I knew it was not the best idea based on the situation. Plus, it would have been a waste of a cartridge.

Sgt. Alex Rodriguez told me he was going to respond to the ER to complete the RRI. I told him to meet Ofc. Wynn and I at the jail because of the actions Adam had displayed. He needed to be put in the custody of the MCDC staff as soon as possible. At the jail, the nurse and Deputies came down to assist. The deputies brought a restraint chair and placed Adam in it without incident. I saw Sgt. A Rodriguez was able to get a picture of Adam's stomach, noting the location of the signature marks. I briefed Sgt. A Rodriguez on what had taken place. I told him I would complete the needed paperwork and place it on his desk. After this, Sgt. A Rodriguez and I left the jail and Ofc. Wynn went upstairs to complete his original DUI investigation with Adam.
