On March 4, 2021, at approximately 1424, I (Ofc Valdes Marrero) responded to the intersection of Fleming St. / Duval St., in reference to an assist for Sgt. Rodriguez who was interacting with a code violation.

Upon arrival, Sgt. Rodriguez and Ofc. Standerwick had a female (later identified as Susan Wildrick) detained in handcuffs. Since I did not witness the interaction between Sgt. Rodriguez and Wildrick, I watched Sgt. Rodriguez body camera footage.

On the footage of the body camera, I observed Sgt. Rodriguez walk up Wildrick. Wildrick was smoking a cigarette on the 500 block of Fleming St. Sgt. Rodriguez tells Wildrick to put a face mask on (as required per city ordinance 21-01). Wildrick tells Sgt. Rodriguez that she is smoking cigarette and proceeds to "shoo him away". Sgt. Rodriguez repeatedly tells Wildrick to wear a face masks, but Wildrick became defensive and belligerent while continuing not wearing a face mask. Sgt. Rodriguez asks Wildrick for her identification to issue her a civil citation. Wildrick said she did not have an identification and tries to walk away from Sgt. Rodriguez.

Sgt. Rodriguez had to physically grab Wildrick by her arm in order to prevent her from walking away. Wildrick became more belligerent and started cursing at Sgt. Rodriguez. At one point, Wildrick told Sgt. Rodriguez "get your fucking hands off of me". Wildrick then proceeds to walk across the street while Sgt. Rodriguez follows her. After Sgt. Rodriguez catches up to Wildrick, she continues to try and pull away from him. After a short time, Sgt. Rodriguez handcuffs Wildrick and calls for another police officer to assist. Sgt. Rodriguez also issued Wildrick a civil citation for violation of city ordinance 21-01 (wearing a face mask required in public). Wildrick has to appear in front of honorable Judge Fowler on March 25, 2021, at 0900 hours. Wildrick signed the citation.

After I watched Sgt. Rodriguez's body camera footage, I placed Wildrick in the back of my patrol vehicle. I transported Wildrick to MCDC without incident. My AXON BWC was not activated because it was left at the station downloading previous case videos. My in-car AXON was activated, and the video was uploaded to the server as evidence.

On 03/4/21, at about 1500 Hours, I, Sergeant Pablo Rodriguez, noticed a municipal ordinance violation occurring in my presence near the corner of Fleming Street and Duval Street. I was on duty assigned to mandatory overtime COVID-19 enforcement on Duval Street.

**INCIDENT**

This incident involves Susan Wildrick who did not apply her face covering as directed by Key West City Ordinance 21-01 ("MANDATE THAT INDIVIDUALS WEAR A FACE COVERING IN PUBLIC"). Key West City Ordinance 21-01 will be referred to as "city ordinance" for the remainder of this report.

I asked Wildrick to wear her face covering. Wildrick did not obey my lawful order to wear her face covering as prescribed by city ordinance, and continued to walk away, as I asked her to wear her face covering. I had to walk faster to catch up and stop her. Wildrick stopped and said she was smoking. I explained there was not a smoking exemption. She said, "Whatever..." I told her to give me her ID so I could issue her a citation and she said "No" and walked away. I explained to her not to walk away or I would have to take her to jail. She responded "I'm fucking smoking" and walked away. I grabbed her arm and ordered her to place her mask on. Wildrick continued to resist verbally and physically by refusing to put on a mask properly and by walking away. I had to stop her to de-escalate her behavior a few times. The interaction was detailed and recorded on my body worn camera. Officer Marrero transported her to the jail. I issued her Citation 4055.

My AXON Body Worn Camera (BWC) was activated during this incident. I later uploaded my BWC footage onto the Key West Police Department AXON Server.
