A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF TWENTY-FOUR (24) 2021 FORD POLICE INTERCEPTOR AWD PATROL VEHICLES FROM BARTOW FORD IN AN AMOUNT NOT TO EXCEED \$1,030,493.64 PURSUANT TO CHARLOTTE COUNTY, FLORIDA CONTRACT 21000541, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST POLICE DEPARTMENT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Charlotte County Purchasing Bid No. 21000541 Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of a total of: sixteen (16) 2021 Ford Police Interceptor Detective Vehicles (\$42,520.01 each), in an amount not to exceed \$680,320.16; five (5) Supervisor Vehicles (\$43,192.01 each), in an amount not to exceed \$215,960.05; and three (3) Patrol Vehicles (\$44,709.01), in an amount not to exceed \$134,127.03; through Florida Charlotte County, Florida Contract 21000541, pursuant to section 2-797(3) of the Code of Ordinances, is hereby authorized in the total amount not to exceed \$1,030,407.24, is hereby authorized for purchase by the Key West Police Department.

Section 2: That funds for the purchase of this equipment

are budgeted FY22 in Infrastructure Surtax Fund, Police Department, Machinery and Equipment account 101-2101-521.64 in an amount up to \$1,022,940.00. The remaining deficit of approximately \$7,500.00 shall be appropriated/transferred from the Infrastructure Surtax Fund Operating Reserve account, 101-1900-519.9803. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
