A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CREATION OF METERED PARKING SPACES IN THE 500, 600, 700, 800 and 900 BLOCKS OF WHITEHEAD STREET, AND THE 200 BLOCK OF ELIZABETH STREET PURSUANT TO SECTION 70-31(a) OF THE CODE OF ORDINANCES; AUTHORIZING CITY STAFF TO WORK WITH THE STATE OF FLORIDA TO OBTAIN A RIGHT-OF-WAY/CONSTRUCTION AGREEMENT PERMIT FOR SUCH METERED PARKING ALONG STATE-OWNED RIGHT-OF WAY ON WHITEHEAD STREET, UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 70-31(a) of the Code of Ordinances authorizes the City Manager to designate parking spaces, and to seek the advice and consent of the city commission for such decisions; and

WHEREAS, the City Commission approved the 2021/2022 Budget on September 23, 2021, with the direction to expand metered parking in the 500 through 900 blocks of Whitehead Streets, and the 200 block of Elizabeth Street; and

WHEREAS, the sections of Whitehead Street are state-owned, and will require approval in the form of a Construction Agreement permit issued through Florida Department of Transportation, District 6; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the designation of metered parking spaces in the 500, 600, 700, 800 and 900 blocks of Whitehead Street, and the 200 Block of Elizabeth Street is hereby approved.

Section 2: There is adequate funding in the FY 21-22 budget for the creation of metered parking spaces, including signage and the installation of up to seven parking pay stations. (The costs are expected to be offset by increased parking revenue.)

Section 3: That City staff is authorized to provide necessary plans and documentation and to execute necessary documents with the Florida Department of Transportation District 6, to install metered parking along the State of Florida-owned right-of-way, upon advice and consent of the City Attorney.
