The Department cannot concur with the City's request for concurrence to award. The City submitted the request for concurrence along with the bid tabs on 8/18/2021. Based on the information provided by the City and further consultation with Central Office, the Department cannot ensure the this project was competitively bid. Title 23 CFR 635.114 requires the construction contract to be awarded based on the lowest responsible bid submitted by a bidder meeting the criteria of responsibility. Furthermore, we noted a high percentage of unbalanced items based on the bid comparison. The bid analysis process, pursuant to 23 CFR 635.114(c) is an examination of the unit bid prices for reasonable conformance with the engineers estimated prices.

Should the City decide to proceed with awarding the contract, it would not be eligible for federal aid. Please advise how the City would like to proceed with the subject project. Feel free to contact me if you have any questions.

- 2. Neither the price(s) nor the amount of this bid have been disclosed to any other firm or person who is a bidder or potential bidder on this project and will not be so disclosed prior to the bid opening.
- 3. No attempt has been made or will be made to solicit, cause, or induce any firm or person to refrain from bidding on this project, or to submit a bid higher than the bid of this firm, or any intentionally high or non-competitive bid or other form of complementary bid.
- 4. The bid is made in good faith and not pursuant to any agreement or discussion with, or inducement from, any other firm or person to submit a complementary bid.
- 5. The Bidder has not offered or entered into a subcontract or agreement regarding the purchase of materials or services from any other firm or person, or offered, promised, or paid cash or anything of value to any other Bidder or person, whether in connection with this or any other project, in consideration for an agreement or promise by any other firm or person to refrain from bidding or to submit a complementary bid on this project.

6. If the local agency has similar requirements in their bidding documents, those requirements would need to be reviewed. Another thing to look at is whether these two bidders are affiliated in any way. If you can provide the names of the bidders, we could look into that. Please advise.
