About the Citizen Review Board Sixty percent of the voters who went to the polls on November 5, 2002, approved an amendment to the Key West City Charter to create a Citizen Review Board (CRB). This is an independent, seven-member, volunteer (unpaid) board with authority to review and/or investigate complaints involving Key West police officers and forward findings and/or recommendations to City management, the Chief of Police, State Attorney, other state and federal law enforcement agencies and/or grand juries. Any applicant for a position on the CRB must complete this application and submit it within the prescribed deadline noted.

The CRB has a policy of delivering its documents and materials via online/internet communications. All applicants must have adequate computer skills to send/receive e-mail, with PDF attachments and be able to access the internet and download documents and files. New CRB members are expected to be available to attend the Annual NACOLE (National Association for Civilian Oversight of Law Enforcement). The expenses for training events shall be covered by the CRB approved budget.

I have known John Strachan as a member of American Legion Post 168 located in Key West, Florida. Mr. Strachan served on the Executive Committee for the past two and one-half (1 1/2) years in the position of Historian. He spent months researching the history of the Post and complied a comprehensive written document detailing how the Post came into being and how the building located at 803 Emma Street came into existence. Along the way he dispelled rumors such as the true story of the sailor for which the Post is named, William Weech. It was originally thought William Weech died on the USS Maine when it was blown up in the Havana Harbor. However, Mr. Strachan's research proved William Weech was killed when the USCGC Tampa was torpedoed off the coast of Wales during World War I. The Post benefited from this information.

Mr. Strachan also attended all of the required courses and obtained the required certificates to become qualified as a "bar manager". He served in that capacity during the Post's Grand Reopening in February, 2020. The Post closed during the early stages of COVID but reopened in May, 2021. Mr. Strachan served as one of three Bar Managers through July of this year.

Mr. Strachan has been an active member working in fundraisers and projects directed at helping the community. He has been involved in the Post's "Brown Bag" Christmas events where children of Bahama Village receive food, treats and presents. He has been present when wreaths have been laid in honor of military service and has marched in parades with the Legion.

Another skill Mr. Strachan brought to Post 168 was the ability to identify available grants which could be obtained and used to repair and reopen the building which is home to the Post. He has been responsible for obtaining thousands of dollars in grant funding. This money was sorely needed to bring the building, which had been condemned by the City, back to code so we could reopen and again begin to serve the community.

1. What aspect of your life and/or work experience has prepared you for membership on the CRB?

I started a career in law enforcement in January of 1974 when I was employed as an officer for the Michigan Public Service Commission, State of Michigan. I would work in a variety of positions and eventually advance to the rank of Sergeant in charge of training. I taught Pursult Driving and weapons. In 1982 we were merged with the Michigan State Police as their Motor Carrier Division. I continued to hold a variety of positions and advanced to the rank of Lieutenant. I commanded the Stolen Vehicle Team, the Hazardous Materials Team and the Specialized Transportation Enforcement Team. I later commanded the Division's First and Sixth Districts (which were geographic regions of the State of Michigan).

I graduated from the Thomas M. Cooley School of Law in 1987. I passed the Bar Examination that same year and soon began teaching on a part-time basis for both the Michigan State Police Training Academy and the state's Fire Fighters Training Council. I taught Civil Liability, Laws of Arrest, Search and Seizure and other classes which required a lawyer to be the instructor.

In 1991 I took an unpaid leave of absence from the State Police to accept a position with one of the state employee unions. In 1993 I opened a private law practice (although I continued as in house council for the union on a part-time basis). As a private attorney I practiced criminal defense among other areas of law. This gave me the opportunity to view law enforcement from another prospective.

In 1997 I returned to the union as a full-time employee and retired in 2016. However, my time in law enforcement and later as a criminal defense attorney gave me an insight many people never acquire. My passion for the law and for law enforcement has remained resolute throughout.
