## **New Case**

The Code Officer was Sophia Docotche. The Respondent Joseph Walsh was present. Assistant City Attorney Nicolas Trovato was present on behalf of the City. The Respondent provided an evidence packet. Officer Doctoche read her timeline. The Respondent asked Officer Doctoche when a violation was found with item 1 on the inspection list did she continue the inspection. Officer Doctoche answered no. The Respondent asked Officer Doctoche if the Licensing Department made the inspection form. Officer Docotche answered that the form was drafted by the Planning and Licensing Department. The Respondent asked Officer Doctoche if she knew if the business was in compliance for the other 8 items on the inspection form. Officer Doctoche answered no and if there was a violation found the procedure is to stop the inspection once one of the sections has failed. The Respondent referenced page 2 section 2 of the resolution 2012-25 and asked if Officer Doctoche answered

yes and referenced where she saw it. The Respondent stated that Officer Doctoche was reading before the mark where he asked her to read from. The Respondent asked Officer Doctoche if she sees any mentioning of seating in the section where it reads "with the conditions provided by the Planning Board the conditions are as follows". Officer Doctoche answered that she does not see seating in the list, but seating is mentioned in the resolution. The Respondent referenced his evidence packet exhibit B page 3 the highlighted section. The Respondent asked Officer Doctoche if she saw any where in the section he referenced if it mentions seating. Officer Doctoche answered no she did not see seating mentioned in the highlighted area in the exhibit he provided. Officer Doctoche stated that her resolution is different than the one he provided. The Respondent stated that conditional use inspections should not include the counting of seats. Assistant City Attorney Nickolas Trovato stated that section 2 the City Commission also added that the Respondent have no more than 150 seats on each floor of the business and the fact that he has more seats on the first floor is a violation of the conditions that the City Commission set forth in granting this particular resolution. The Respondent stated that we are not here for having too many seats and that we are here for a failure to pass a conditional use inspection. The Respondent continued to argue the charges against him and the Special Magistrate decided that a continuance might be the best thing to do. The Special Magistrate granted the continuance to 28 September 2023.

Assistant City Manager Todd Stoughton was present on behalf of the City. Officer Young read his timeline. Officer Young stated that there were witnesses the City would call upon for this case. The first witness for the City Matt Willman stated that it is customary to have the back utilities which is for the sewer paid for to get the LUD and he stated exactly how much the Respondent owes. The Respondent asked Matt Willman a series of questions and Matt answered his questions. The Special Magistrate stated that if the Respondent wants to argue about the amount of fees that are owed for the LUD then he will have to take that up with the City and also said that there was an admission to having owed back fees to the City. The Respondent stated that he did not admit to the violation that he had rented the whole house out to a single family and they used the whole home. The Special Magistrate asked why did he apply for a LUD. The Respondent stated that he wanted an affordable work force housing for the residents of Key West so that they can keep an eye on the whole property while he is out of town. Officer Young stated that the Respondent applied for the LUD and the Planning Department requires certain information and the cut off date for the back utilities fees went back to 1993 and since then has been changed to 2010. The Respondent provided information that there is two units on the property and we are not here questioning if he rents it or not. The Respondent also provided evidence from Keys Energy showing electricity being used in two units starting April 30th 1998 going until November 1st 2011. The fact is, is that the Respondent applied for a LUD then Matt did the calculations for the back utilities pay and now the Respondent refuses to pay. Officer Jim Young stated the next witness is Assistant City Manager Todd Stoughton. Officer Young went on to ask Assistant City Manager Stoughton about his involvement in the case that the Respondent reached out to him to waive the fees for the Respondent. Assistant City Manager Stoughton answered yes and he gave him other avenues for him to try to do that. Officer Young also asked if the Respondent had tried to do anything he had suggested and the answer was no. The Special Magistrate thought there was substantial evidence for a finding of the violation and imposed \$250.00 administrative cost and \$250.00 per count per day if not in compliance by 29 August 2023.
