Neither respondent was present at the meeting but Mr. Jack Sengupta was in correspondence with the City of Key West Urban Forestry Manager and had indicated his wishes to enter into a Compliance Settlement Agreement with the Tree Commission. A motion was made by Ms. Robin Robinson, seconded by Mr. Robert Bethel, that:

- 1) The respondent (Jimmy Whitley) shall pay a fine of \$500 to the City of Key West Fund.
- 2) The respondent (Jack Sengupta) shall hire a certified arborist to maintenance trim the (2) Spanish Lime trees within (3) months of the date of the signed document and shall make sure that the property owner (Steven Eib) gives his permission for access to the property in order for the arborist to trim the tree. Also, the respondent (Jack Sengupta) shall hire a certified arborist to maintenance trim the (2) Spanish Lime trees (1) year from the date of the first trim and have the City of Key West Urban Forestry Manager inspect the tree after each maintenance. The respondent (Jack Sengupta) is to agree to always use a certified arborist for any future tree trimming work.

When asked by the Tree Commission Chairman David Jackson, the respondent (Shirlee Ezmirly) indicated her wishes to enter into a Compliance Settlement Agreement with the Tree Commission. A motion was made by Ms. Robin Robinson, seconded by Mr. Kent Ducote, that:

The respondent (Shirlee Ezmirly) shall hire a certified arborist to document the health of the entire tree and submit a report to the Tree Commission that includes a plan to repair the drill holes and a recommendation as to the future of the tree, within (3) months of the date of the signed document. The respondent (Shirlee Ezmirly) shall also hire an entomologist to determine the extent of any insect infestation in the tree and submit a report to the Tree Commission that includes a plan to repair the drill holes and properly treat the tree, within (3) months of the date of the signed document. The City of Key West Urban Forestry Manager shall review the requested documents and determine the best course of future action for the tree. The respondent (Shirlee Ezmirly) shall pay a fine of \$1000 to the City of Key West Tree fund within (6) months of the final date of the agreement.
