-- John David Eltringham Arrest Narrative:

On Sunday March 20, 2022, at about 1827 hours, I, (Ofc. L. Hernandez), was dispatched to the area of Grinnell and Angela Street, reference a domestic violence incident.

Upon arrival, I met with a male, later identified as John Harold Cunningham (DOB 06/23/1960) (witness), who flagged me down and advised me the male and female involved in the domestic violence incident were walking together on Angela Street towards White Street.

As I was driving towards White Street, I could see the female walking in front of the male, as she was trying to get away from him, at about 50-75 feet apart from each other. I caught up to the male, John David Eltringham (DOB 08/25/1974) (Arrestee), identified by his Maryland driver's license. John was visibly and evidently upset, I asked him to stop and face me, he hesitated but did stop. I ordered John to stop and have a sit on the curb and he began to scream and refused. I asked John several more times to comply and he began to make movements towards the direction of his wife, Amy Louise Eltringham (DOB 01/23/1975) (victim). I ordered John again to stop and have a seat and he said he was not going to comply. Ofc. R. Hartle arrived on scene to provide backup assistance and asked John to comply, and John declined. I unholstered my taser and pointed towards John's direction. I warned John he was going to get tased and he said "tase me, I don't care, tase me". I ordered John again to comply and he again refused and made movements towards the direction of his wife again. I deployed my taser to physically control John. The taser probes contacted John's left side of his torso causing John to fall down to the ground through neuromuscular incapacitation.

Once on the ground, I immediately ordered John to place his hands behind his back, I placed him in handcuffs, checked them for tightness and double locked them. I then place John in a recovery position and removed both probes from his body while using personal protective equipment (gloves). John's active resistance behavior by making movements towards his wife while being ordered to sit down after being warned multiple times to comply by myself and Ofc. Hartle and his physical statue (John is 6'3" 270 lbs) gave us no other alternative to control the volatile situation but to use my taser. I believe due to the totality of circumstances the force I used was reasonably necessary. Key West Rescue 1 arrived on scene and after assessing John medically, they transported him to Lower Keys Medical Center Emergency Room for further treatment. After John was medically cleared by the ER I transported him to the Monroe County Detention Center where he was turned over to Detention Deputies without issues.

Cunningham, who witnessed the incident between John and Amy, completed a sworn written statement where he noted John was standing over Amy, while she was on the ground screaming from the top of her lungs for help. Cunningham goes on to say that Amy eventually gets up and walks away from John and he followed her. Amy had a scraped right knee with some fresh blood emanating from it and some red marks on her face. When I asked Amy what had occurred and how she sustained her injuries she refused to talk to me other than saying she just wanted to go back home. John had a few scratches on the right side of his neck. When I asked John what had occurred and how he sustained the scratches to his neck he did not want to talk to me about it. Both John and Amy were under the influence of alcoholic intoxicant (s) as per their strong odor of alcoholic beverage (s) emanating from their breath, flushed faces, and droopy eyes. John and Amy are currently married for over 28 years, have 2 children in common and reside together. This incident meets the criteria of domestic violence as described if FSS 741.28. I provided Amy with a victim's rights brochure and explained to Amy her rights. The brochure had my full name, ID # and case number written on it.

According to the witness statement, based on all facts, evidence and totality of circumstances I believe John was the primary aggressor in this domestic violence incident. I believe John has committed the misdemeanor criminal offense of battery touch or strike in violation of FSS 784.03 - John actually and intentionally touched and struck Amy causing bodily harm against her will.

Based on all facts, evidence, and totality of circumstances, I believe John committed the misdemeanor criminal offense of resisting an officer without violence to his / her person as described in FSS 843.02. John was encountered by two uniformed police officers, Ofc. Hartle and I were wearing our Key West Police Class B issued uniforms that clearly identifies us as police officers. John resisted our lawful commands and tried to move away from us as we were lawfully ordering him to stand down and was warned multiples times to comply to no avail as we were trying to conduct our investigation.

Sgt. J. Hammers responded to the scene and completed a response to resistance report.

My BWC and Axon Fleet (3452) were both activated during this incident and have been uploaded to Evidence.com

On Sunday 3-20-2022 close to 6:30 pm, I (Officer Hartle) heard a call come out over channel 1 about a domestic battery in progress between a male and female at Angela Street and Grinnell. I was working a special traffic detail and about to call off duty when this call came out. The caller said a woman was on the ground screaming for help. I went to this location and found a man walking his dog. He pointed in the direction of Angela and Frances Street. He advised that the male and female had walked off in that direction (and pointed to the east). I started that way and saw Officer Hernandez out in the roadway in front of 1105 Angela Street (Just east of Frances Street). As I pulled up, I Heard Officer Hernandez giving loud verbal commands to a large white male (Later identified as John Eltringham). Eltringham was in a slightly bladed fighting stance with his arms out and appeared very angry. He was not listening to Officer Hernandez, so I verbally engaged him also told him to sit down. Eltringham seemed very intoxicated and was bleeding from his nose. Eltringham then moved out of the street onto the sidewalk with his back to the fence. Eltringham was still acting very aggressive and was yelling that he was not going to sit down. Eltringham was then advised that he would be tased if he did not listen. He then yelled to fucking tase me then. Officer Hernandez did tase Eltringham. Eltringham was then secured, and Officer Hernandez placed him in hand cuffs. Other officers started arriving and with the scene in control, I cleared with an assist. My BWC was activated while securing Eltringham.
