A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED AMENDMENT 2 OF THE PUBLIC TRANSPORTATION GRANT AGREEMENT ("PTGA") #G2T51 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST EXTENDING THE TERM OF THE GRANT AGREEMENT TO DECEMBER 31, 2026; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS AND NECESSARY BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 24-050, the City Commission approved to PTGA #G2T51 to purchase miscellaneous and shop equipment; and

WHEREAS, funding through the FDOT Section 5339 Rural Bus and Bus Facility Capital funds, provides Capital assistance for the purchase of support equipment for buses and transit facility; and

WHEREAS, the City requested an extension of the grant term from January 2026 to December 31, 2026, to meet various purchasing requirements; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Commission hereby approves Amendment 2 of the Public Transportation Grant Agreement ("PTGA #G2T51") FM #452576-1-94-23 between FDOT and the City,

extending the grant agreement from January 12, 2026 to December 31, 2026.

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers, budget amendments, project scope, and extension in accordance with such grant, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
