#### **DESCRIPTION:**

Staff Restroom Revisions

Furnish and install the revisions shown in the HC Staff Restroom in accordance with drawing ID2.4 dated 11.18.24. Revisions include addition of durarock with waterproofing at walls, new 12 x 24 tile at walls with Schluter stop, porcelain lav and toilet, and new shower assembly with associated rough-in as shown. An allowance of \$3.99/sf is included for tile materials.

Fence Value Engineering and Site Revisions

Provide revisions to the site fencing in accordance with the City's response to email subject John Jones Navigation Center Options for Revising Site Fencing dated 11/19/24 and revised drawing A-3.0 R6 dated 8-06-2024 reflecting the revised loading zone, trash, and recycling. This change also includes fence modification and gate modification required by the Sheriff's Department in order for existing fencing to be demolished as shown on the plans. Revisions are as follows:

- 1. Credit to change all wood fence to black vinyl coated chain link fence
- 2. Credit to change aluminum fence on retaining wall to black vinyl coated chain link fence
- 3. Provide additional LF of chain link fence as required for revised dumpster and recycling layout on A-3.0
- 4. Provide additional temporary fence as directed by Monroe County Sheriff during demolition of existing fence to protect impound yard
- 5. Provide modification of impound yard sliding gate as directed by Monroe County Sheriff for demolition of existing fence
- 6. Furnish previously purchased Simpson wood fence brackets to City of Key West due to change to chain link.
