A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RENEWING FOR TWO YEARS THE GENERAL ARCHITECTURAL SERVICES CONTRACTS WITH EIGHT (8) FIRMS, ORIGINALLY AWARDED IN RESOLUTION 17-190 IN RESPONSE TO REQUEST FOR QUALIFICATIONS NO. 17-001 FOR GENERAL ARCHITECTURAL SERVICES; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution 17-190 the City Commission approved eight (8) architectural firms to provide General Architectural Services for the City of Key West, and authorized the City Manager to negotiate three-year contracts with the option of a two-year renewal at the option of the City; and

WHEREAS, City staff recommends exercising the two-year renewal option for each engineering firm; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That contracts for general architectural services are hereby renewed for a term of additional two years, upon mutually agreed terms for the following eight (8) firms:

- (2) Hayes/Cumming Architects
- (3) K2M Design
- (4) PFB Architects
- (5) Rodrigues & Quiroga
- (6) Salz-Michelson Architects
- (7) William P. Horn
- (8) Wood Environment and Infrastructure Solutions
(name change from AMEC approved in Res 18-148)

Section 2: That the City Manager is hereby authorized to execute a two-year renewal upon agreed terms for each of the above-described contracts, upon the advice and consent of the City Attorney.

Section 3: Specific task orders issued pursuant to the contracts shall continue to comply with the City's procurement guidelines.

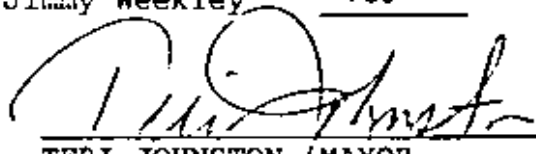
Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.

Action Statement

Approve two (2) year extension of General Architectural Services Contracts for below listed firms. Authorize City Manager to execute the extensions.

Background

Resolution 17-190 awarded three-year General Architectural Services contracts to below listed firms in response to RFQ 17-001: *Architectural Services*. In accordance with Article 4 of the agreements, a single two-year renewal is authorized at the discretion of the City. Current agreements expire end of August 2020. Firms to be extended are:

2. Hayes/Cumming Architects
3. K2M Design
4. PFB Architects
5. Rodriques & Quiroga
6. Salz-Michelson Architects
7. William P. Horn
8. Wood Environment and Infrastructure Solutions, Inc.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE STAFF RANKING FOR GENERAL ARCHITECTURAL SERVICES IN RESPONSE TO RFQ NO. 17-001; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND ENTER INTO CONTRACTS ON A TASK ORDER BASIS WITH SELECTED ARCHITECTURAL FIRMS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE
