CITY COMMISSION MEETING

TUESDAY, OCTOBER 18, 2011

A regular meeting of the City Commission of the City of Key West, Florida was held in Commission Chambers, Old City Hall, on Tuesday, October 18, 2011.

Mayor Craig Cates called the meeting to order at 6:02 p.m.

City Attorney's Report

City Attorney Smith welcomed Commissioner Yaniz to the Commission.
