Good Afternoon Dr. Taylor,

I received your message today after my return from the FPTA conference. Thank you for addressing us at the conference as well.

The City of Key West has submitted a project through Trams for participation in the relief program. Some of the issues I had conveyed before are the lack of funding to have already completed this repairs and the failure of contractors to respond to our requests for quotes. Therefore it is difficult to produce a document outlining the repair costs actual or estimated. Since the approval of our budget on 1 October, we will be able to assemble a solicitation that is funded for the repair or replacement of the generator. So we will have better backup at that point.

The process is a bit confusing since we are trying to answer requests from the folks we submitted the application in Trams and from other points of contact at FTA. We of course want to comply in every way and appreciate your assistance through this complicated process.
