A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST (CITY) APPROVING PURSUANT TO SECTION 2-797(4) OF THE CODE OF ORDINANCES A CHANGE ORDER IN THE AMOUNT OF \$75,197.34 FOR ADDITIONAL NECESSARY TASKS, UNDER THE CONTRACT AWARDED TO REYNOLDS CONSTRUCTION OF FLORIDA, LLC AWARDED UNDER ITB #23-007 FOR RICHARD A. HEYMAN ENVIRONMENTAL PROTECTION FACILITY RAS AND WAS PUMP SYSTEM REPLACEMENT PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS AND AMENDMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS UPON ADVICE AND CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, through City Commission Resolution 23-191 a contract was awarded to Reynolds Construction of Florida, LLC for Return Activated Sludge and Waste Activated Sludge system (RAS and WAS) at RAHEPF; and

WHEREAS, additional tasks have been identified, including replacing concrete pipe supports, lining or replacement and reorientation of certain drainage pipes and related tasks necessary to complete the project in the most efficient manner, at a cost of \$75,197.34; and

WHEREAS, City staff recommends approval of the additional work, pursuant to ordinance section 2-797(4), best interests of the City; and

NOW, THEREFORE, BE IT RESOLVED BY CITY COMMISSION OF THE CITY OF KEY WEST, AS FOLLOWS:

Section 1: That the attached Change Order in the amount of \$75,197.34 for additional tasks, as described in the attached Proposals from Reynolds Construction of Florida, LLC, is hereby approved.

Section 2: That a transfer of funds from account no. 401-3504-535-9900 (other uses) to FY 25 account #401-3504-535-6500 (Construction in Progress) is hereby authorized for this change order. Any related necessary budget transfers or amendments are hereby authorized.

Section 3: That the City Manager is authorized to execute documents related to this Change Order, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
