

**RESOLUTION NO.**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING KREWE OF KEY WEST CORP TO CONDUCT A COSTUME BALL AT THE TRUMAN WATERFRONT AMPHITHEATRE ON FEBRUARY 3, 2018 FROM 8:00 P.M. TO 12:30 A.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Krewe of Key West Corp. wishes to conduct a Costume Ball at the Truman Waterfront Amphitheatre between the hours of 8:00 p.m. to 12:30:00 a.m. on February 3, 2018; and

**WHEREAS**, this event shall take place on the grounds of the Truman Waterfront Amphitheatre during the hours of 8:00 p.m. to 12:30 a.m. on February 3, 2018; and

**WHEREAS**, the sponsors anticipates that amplified music will be played during the event;

**NOW THEREFORE, BE IT RESOLVED**, by the City Commission of the City of Key West, Florida;

**SECTION 1.** That Krewe of Key West Corp is hereby granted permission to conduct a “Costume Ball” on the date and during the hours stated above; PROVIDED all trash is adequately collected and contained; guarantee indemnifying the City is executed; and the organizations meet the terms and conditions set forth by the City Manager.

**SECTION 2.** That pursuant to Section 18-86 of the Key West Code of Ordinances, Krewe of Key West Corp is hereby granted permission allowing the sale and consumption of alcoholic beverages within an enclosed area.

**SECTION 3.** That Krewe of Key West Corp. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time herein described.

**SECTION 4.** that Krewe of Key West Corp. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used that that they will be placed side by side.

**SECTION 5.** that Krewe of Key West Corp will be responsible for the user fee of 500.00, a 500.00 refundable deposit as well as any other cost associated with the event.

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
