A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING “INTEGRITY MULTISPORT, INC” & REEF RELIEF, INC.” TO CONDUCT A “KEY WEST TRIATHLON/TRI CONCH REPUBLIC EVENT STARTING AT 7:00 AM AND ENDING AT 11:00 AM, DECEMBER 4TH, 2021 (SET-UP, FRIDAY, DECEMBER 3, 2021 FROM 11:00 AM TO 3:00 PM) AT SMATHERS BEACH AND PARKING LOT ACROSS SMATHERS BEACH ; AUTHORIZING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Integrity Multisport, Inc. and Relief, Inc is hereby given permission to conduct a Triathlon on Saturday, December 4th, 2021;

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law.”

SECTION 2. That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/lessee/licensee/contractor therefore commits to refrain from the use of distribution of single-use polystyrene/plastic items, including but not

limited to single-use polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City.”

SECTION 3. That permission is hereby granted to conduct the Integrity Multisport, Inc.

and Reef Relief, Inc on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 4. That Integrity Multisport, Inc and Reef Relief, Inc. is hereby granted permission for the closure of certain streets throughout the city for the Key West Triathlon/Tri-Conch Republic on the date and during the hours stated above.

SECTION 5. That Integrity Multisport, Inc. and Reef Relief, Inc. will be coordinating with the agencies outside of the City of Key West jurisdiction for their part in the race.

SECTION 6. That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That the event organizer shall use spray chalk or another readily removable substance for all course markings placed on public property.

SECTION 8. That the applicant acknowledges this authorization may be revoked by the Commission or the City Manager, due to exigent circumstances such as the resurgence of COVID-19 in the community.

SECTION 9. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
