Supplemental Narrative By Jeremiah Osborne, 10/14/25 15:58

On October 14th, 2025, I (Ofc. Osborne) was at the KWPD station writing up a warrant for Pablo Sanchez's arrest. I later heard over the radio that Ofc. Abreu had eyes on Pablo around Catherine St and George St. I later left the PD station and went to assist in the search. I later was traveling on George St, and I heard DET Roberts advise that he had seen Pablo riding through 1200 1st St. (George Allen) wearing a black long-sleeve t-shirt and blue shorts. I arrived at 1200 1st St. on the Fogarty St side and observed Pablo riding his bicycle through the street. I then exited my patrol vehicle and began running toward him. While running, I was pointed to the L building on George St, and I observed Pablo running towards 1st St.

Det. Hesse and I continued to run after Pablo, giving him numerous verbal commands to stop, but he refused. Pablo later exited George Allen and began running onto 1st St., where he ran into a vehicle. Det. Bozzetti and Sgt. Malsheimer later arrived and Det. Bozzetti displayed his taser and shot Pablo with his taser. Pablo later tripped and

was tackled by Sgt. Malsheimer. Det. Bozzetti and I later assisted Sgt. Malsheimer in getting Pablo in handcuffs. Pablo later looked at me and stated, "Your name is Jay, right?". I later asked Pablo how he knew that, and he stated, "Cmon, I know who you are, and everyone has been telling me that you were out on the hunt for me."

I later read Pablo Marinda's warning, which he agreed to speak with me. (SEE Det H DeValle BWC for the conversation) I later began asking Pablo if he remembered an officer attempting to pull him over on Monday morning. Pablo stated he did remember that, but he did not know it was me at the time. He did not stop because he knew he had warrants. I later advised Pablo of his pending charges.

I later asked KWFD, who arrived on the scene, to conduct an assessment on Pablo. Ofc. Arguello later took custody of Pablo.

Supplemental Narrative By Erik Roberts, 10/14/25 16:05

Roberts Supplemental

On Tuesday 10/14/2025 I (Det. E. Roberts) responded to the area of George St/Catherine St in reference to a wanted subject (Pablo Sanchez 07/21/1995).

Upon my arrival to the area I was travelling southbound on George St. When I observed Sanchez (Known to me from previous law enforcement encounters) riding a light-blue in color E-bike turning northbound onto George St from United St. I notified other responding Officers and quickly turned northbound (against the flow of traffic) on George St when I observed Sanchez turn eastbound, apparently onto Vivian St. Another Officer transmitted that Sanchez had turned into George Allen Housing Complex (1200 1st St). I continued to the east side entrance (From 1st St). While entering the complex I observed Sanchez riding northbound on the back side of the J-L buildings. As I approached in my vehicle Sanchez turned towards George St. between the L and M buildings followed by Ofc. J. Osbourne. I relayed his direction of travel to other responding officers and exited my vehicle to follow on foot. I then heard Ofc. Osbourne announce himself as Key West Police and command Sanchez to stop. Sanchez continued to run eastbound through the complex towards 1st St. I returned to my car and began driving towards 1st St when I heard radio traffic that Sanchez was in custody.

I had no further involvement in this incident.

Supplemental Narrative By Joshua Hesse, 10/14/25 16:34

On Tuesday, October 14, 2025, at approximately 1443 hours I, Detective Joshua Hesse, was in an unmarked vehicle along with Detective Henry del Valle. While in the area of United St and White St, detectives C. Bozzetti and Sgt. K. Malsheimer advised they observed a known wanted subject, Pablo Sanchez.

Multiple patrol officers along with SIU detectives came into the area and began searching for Sanchez who had multiple warrants for his arrest. I was advised a moment later Sanchez was running from police, southbound on George St. I observed Sanchez a moment later wearing blue shorts and a black long-sleeve shirt, running southbound along the public housing complex, located at 1200 1st St.

I began chasing Sanchez on foot as he ran between two buildings and began slowing behind a dumpster in the parking lot. While wearing a ballistic vest emblazoned with the word "POLICE" in bold letters on the front and rear, I loudly identified myself as a police officer, ordered him to "stop", and told him he was under arrest.

Sanchez turned and made eye contact with me and responded by turning his body and running further into the George Allan apartment complex. I observed Ofc. J. Osborne at about that time also running after Sanchez. Sanchez ran through the housing complex and across 1st St where I observed Det. Bozzetti and Det. Sgt. Malsheimer running towards Sanchez, southbound on 1st St.

I observed Det. Bozzetti discharge his Taser toward Sanchez and observed him fall about the same time. Sanchez

was quickly secured in handcuffs and assessed for injuries. KWFD rescue was called to assess Sanchez due to the Taser exposure, as well as a reported new injury to his left lower leg.

Ofc's. V. Arguello and G. Abreu arrived took custody of Sanchez. Ofc. Arguello assumed primary control of the incident.

I had no further involvement in this incident.

Supplemental Narrative By Christian Bozzetti, 10/15/25 15:16

On 10/14/2025, around 14:40 hours, Det. Sgt. Karl Malsheimer and I (Det. Christian Bozzetti) heard patrol officers advising over the radio that a subject with an active arrest warrant (Pablo Sanchez) was attempting to flee from them on foot. Patrol advised Sanchez was running East through "George Allen Apartments" (1200 First St).

Det. Sgt. Malsheimer and I were only a few blocks away from Sanchez's location. We got into an unmarked vehicle and drove to the corner of First St. and Roosevelt Dr. I was wearing my vest which clearly displays the word "POLICE" on the front and back of the vest. As we approached the East side of the apartment complex, I could see Sanchez running through the middle of it toward First St. We exited the vehicle and began chasing him on foot. I was able to get close enough to deploy my department issued Taser at Sanchez. I deployed the first set of probes, however, they were ineffective, and he continued to actively resist and attempt to escape capture. I quickly deployed the second set of probes and Sanchez fell to the ground. Det. Sgt. Malsheimer quickly gained control of Sanchez and kept him under control until I placed him in handcuffs. Ofc. Osborne also assisted in controlling Sanchez once he was on the ground.

After Sanchez was in handcuffs, he was assessed for injuries. It is unclear if any of the Taser probes I deployed hit him, as no probes were still attached to him at the time of the medical assessment. Sanchez had some minor injuries which were photographed on scene. He was transported to LKMC by the KWFD for further medical evaluation. Det. Sgt. Malsheimer was able to retrieve one of the probes I deployed, the other three were not found. He collected them and later submitted them to the KWPD Property and Evidence Division as evidence.

My BWC was active during this incident. Det. Sgt. Hammers completed the RRI for this incident.

No further involvement.

Supplemental Narrative By Karl Malsheimer, 10/16/25 13:50

On October 14, 2025, at approximately 1445 hours, Detective Bozzetti and I (Detective Sergeant Malsheimer) were in an unmarked vehicle together when we spotted a wanted male suspect (known to me from previous law enforcement encounters as Pablo Sanchez) riding a bicycle on the 1800 block of Fogarty Avenue. Sanchez quickly went out of my view. Detective Bozzetti relayed our observation to KWPD patrol officers, who responded by setting up a perimeter. Officers in the area gained visual of Sanchez. Sanchez fled from police on foot. I gained visual of Sanchez as he ran across First Street toward the easement between Roosevelt Drive and Patterson Avenue. Sanchez was clearly being chased by officers. Detective Bozzetti and I ran toward Sanchez and came into a closer proximity to him at the easement. Detective Bozzetti deployed his Taser two times towards Sanchez. Sanchez fell into the yard of a nearby residence. Sanchez made movements to begin standing back up (presumably to continue fleeing). I mounted Sanchez before he was able to stand up and took him back down to the ground and maintained control of him. Detective Bozzetti and Officer Osborne assisted in handcuffing Sanchez, and I disengaged. I took possession of the two expended Taser cartridges and the single probe I was able to recover. I placed the cartridges into the KWPD Property & Evidence Section. I took photographs of Sanchez which I later uploaded to Evidence.com. Detective Sergeant Hammers completed the Response to Resistance Report.
