

SAB RESOLUTION NO. 26-01

**A RESOLUTION OF THE SUSTAINABILITY
ADVISORY BOARD OF THE CITY OF KEY WEST,
FLORIDA, SUPPORTING AND RECOMMENDING THE
CITY OF KEY WEST COMPREHENSIVE SAFETY
ACTION PLAN; PROVIDING FOR AN EFFECTIVE
DATE**

WHEREAS, tragically, twenty-five (25) people were killed in roadway crashes within the City of Key West during the years from 2016 through 2020 according to the National Highway Traffic Safety Administration reporting; and

WHEREAS, Resolution 09-024 created the Sustainability Advisory Board to advise and assist the City Commission in efforts to make City operations and the community as a whole more sustainable; and

WHEREAS, Resolution 20-009 directed staff to work with the County and State to create policies and goals for right-of-way projects to incorporate "Complete and Sustainable Streets" and the target of "Vision Zero", setting a "Vision Zero" goal to achieve zero collision-caused right-of-way fatalities and serious injuries by the year 2035; and

WHEREAS, the City of Key West City Commission approved Resolution 23-228 authorizing a grant agreement with the Federal Highway Administration division of the United States Department of Transportation for funding a City of Key West Comprehensive Safety Action Plan in support of "Vision Zero";

and

WHEREAS, Resolution 24-243 authorized the City Manager to execute a contract with University of Florida Transportation Institute (UFTI) to support the drafting of a Comprehensive Safety Action Plan; and

WHEREAS, UFTI researchers worked with Safety Action Plan Task Force stakeholders representing local police, EMS, and transportation; Monroe County schools and transportation; Florida Department of Transportation; and community advocates to evaluate proven safety countermeasures.

NOW, THEREFORE, BE IT RESOLVED BY THE SUSTAINABILITY ADVISORY BOARD OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the Sustainability Advisory Board finds that accepting and adopting the Comprehensive Safety Action Plan will enhance the health and safety of residents of the City of Key West.

Section 2: That the Sustainability Advisory Board recommends the City Commission of the City of Key West accept and adopt the City of Key West Comprehensive Safety Action Plan.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication

by the signature of the Presiding Officer and the Clerk of the Sustainability Advisory Board.
