FREE OUTDOOR MOVIE PROGRAM
- REVOCABLE LICENSE 2023-24

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE CITY OF KEY WEST TO ENTER INTO THE ATTACHED "REVOCABLE LICENSE AGREEMENT FOR NONPERMANENT USE OF CITY PROPERTY" WITH THE KEY WEST FILM SOCIETY (DBA TROPIC CINEMA, INC.), A 501(c)3 CORPORATION, TO ALLOW THE OPERATION OF A FREE OUTDOOR "MOVIES UNDER THE STARS" PROGRAM ON EATON STREET BETWEEN DUVAL AND WHITEHEAD IMMEDIATELY ADJACENT TO 416 EATON STREET ON SPECIFIC DATES SET FORTH IN THE AGREEMENT, UPON ADDITIONAL TERMS AND CONDITIONS CONTAINED IN THE AGREEMENT (NOVEMBER 4, 2023-APRIL 6, 2024); PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-939 of the Code of Ordinances of the City of Key West, Florida allows the City to grant a revocable license for a nonpermanent use of City property; and

WHEREAS, the City Commission finds that a regularly scheduled free outdoor movie events provide local access to family-friendly films and culture, and hereby provides a benefit to residents and visitors;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the City Manager is hereby authorized to execute the attached "Revocable License Agreement for Use of City Property" (the "Agreement") between the City and Key West Film Society, Inc. (dba Tropic Cinema, Inc., a 501(c)3 not-for-profit corporation) for the use of a designated area Eaton Street, immediately adjacent to the Tropic Cinema at 416 Eaton Street for free outdoor "Movies Under the Stars" event series, on dates set forth in the attached Exhibit, upon specific terms and conditions set forth in the Agreement (November 4, 2023-April 6, 2024).

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
