**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT TO THE KEY WEST BUSINESS GUILD FOR A STREET FAIR FOR WOMENFEST TO TAKE PLACE ON SATURDAY, SEPTEMBER 11, 2010 DURING THE HOURS OF 12:00 NOON. TO 8:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 700 & 800 BLOCKS OF DUVAL STREET DURING THE HOURS OF 10:00 A.M. TO 10:00 P.M; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 9:00 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN AN ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** The Key West Business Guild wishes to conduct a street fair for Womenfest on the day and during the hours stated above; and

**NOW THEREFORE, BE IT RESOLVED,** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That the Key West Business Guild is hereby granted permission to conduct a Street Fair on the day and during the hours stated above; PROVIDED all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1000.00, whichever is greater, shall be donated to the Key West Business Guild Fund.

**SECTION 2.** That the Key West Business Guild is hereby granted permission for the closure of the 700 & 800 blocks of Duval Street on the date and during the hours stated above.

**SECTION 3.** That the Key West Business Guild is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 4.** That the Key West Business Guild is hereby granted an exemption from

the sound control ordinance under section 6-86 of Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 5.** That the Key West Business Guild will adhere to the recycling plan of the City of Key West

**SECTION 6.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
