**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, GRANTING A SPECIAL EVENT PERMIT TO WOMANKIND, INC. FOR A FUNDRAISER EVENT LOCATED AT THE INTERSECTION OF ANN STREET AND GREENE STREET: PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 7:00 P.M. TO 10:00 P.M. ON WEDNESDAY, OCTOBER 9, 2024; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS** Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance; and

**WHEREAS** Womankind, Inc. has applied to the city for a Special Event Permit for their event “Tats for Tatas” to take place on Wednesday, October 9, 2024, from 7:00 p.m. to 10:00 p.m.

**WHEREAS** Womankind, Inc. will be partnering with bar establishment, Tattoos & Scars Saloon, to hold a silent auction that will take place at the intersection of the 200 Block of Ann Street and the end of Greene Street.

**WHEREAS** amplified music will be played during the event.

**NOW THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida:

**SECTION 1.** That in Resolution 19-174, the City Commission directed the city Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law.”

**SECTION 2.** “That the vendor/lessee/licensee acknowledges the City’s concern

about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and “To go” packages for food or products sold on any property leased from the City.”

**SECTION 3.** That Womankind, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the place and time as herein described.

**SECTION 4.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
