

Condition: 40% (the tree is in poor health, the tree is flowering and has a very nice canopy, but there

is a massive active termite colony within the crotch of the tree)

Location: 40% (growing in and behind small, single-story condo buildings)

Species: 100% (on City of KW protected tree list)

Tree Value: 60%

Required Mitigation: 15 caliper inches

RECOMMENDATION: The tree has a massive, very active termite colony in the crotch of the tree. Because poincianas hollow out quickly from termites, removal is recommended as this tree is over 3 buildings and would pose a safety risk if limbs start falling.
