



## CLAIM REVIEW/SUMMARY

Employee **George Villareal** has requested to settle his claim. He has agreed to accept \$25,000.00 and resign his position once the settlement is completed. At this time he is not represented by an attorney. He is currently a police officer with the City of Key West. On 12/18/2009 he injured his left ankle.

He has been receiving palliative care with Dr. Loeffler. His diagnosis is continued ankle instability – work related, and arthritis - not work related (condition denied 03/01/10). On 02/19/2010 Dr. Loeffler recommend a Brostrom Lateral ankle reconstruction due to his instability. Since the employee opted not to get the surgery; Dr. Loeffler placed him at MMI 4% on 07/14/10. He has continued with palliative treatment and remained at a full duty work status.

Mr. Villareal has stated, if he does not settle his claim that he will proceed with surgery. If surgery reconstruction is completed, he may not be able to go back to his position as a police officer due to permanent restrictions. This would open us up to TTD/TPD payments for the full 104 weeks. His compensation rate is \$713.90 a week. If he is paid the full 104 weeks we have a potential of paying \$74,245.60. The costs of surgery, therapy, medication, field case management, and follow up care have been considered and will greatly exceed the \$25,000.00 settlement requested.
