## RESOLUTION NO. 23-245

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE "PUBLIC TRANSPORTATION GRANT ATTACHED BETWEEN AGREEMENT" (PTGA) THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST, IN AN AMOUNT UP TO \$250,000 IN OPERATING ASSISTANCE (50% OF TOTAL PROJECT COST OF \$500,000) FOR THE CITY OF KEY WEST ENHANCE OPERATIONALIZES DATA TO SERVICES (CODES) / KEY WEST RIDES ON-DEMAND BUS SERVICE IN KEY WEST AND STOCK ISLAND [FINANCIAL PROJECT NO.452158-1-84-01; PTGA #G2M70]; AUTHORIZING THE CITY MANAGER TO EXECUTE EFFECTUATE NECESSARY DOCUMENTS AND NECESSARY BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the State of Florida Department of Transportation (FDOT), provides a Service Development Grant Program designed to provide start-up funding for new public transit projects that provide new or innovative techniques to improve system efficiencies, ridership or revenues. Under this program the City of Key West has requested 50% reimbursement of the CODES/Key West On-Demand operating costs; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" is hereby approved, between FDOT and the City, in an amount up to \$250,000 [50% of total project cost of \$500,000] of operating costs for the CODES/Key West On-

Demand Bus Service in Key West and Stock Island [Financial Project No. 452158-1-84-01; PTGA #G2M70].

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers in accordance with such grant, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
