A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION GRANT AGREEMENT" (PTGA) BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR STATE FISCAL YEAR (SFY) 2026 STATE TRANSIT BLOCK GRANT FOR THE TRANSIT BUS SERVICE, IN THE CITY OF KEY WEST (PTGA #G3F98 / FM #436702-7-84-01) IN A REIMBURSEMENT AMOUNT OF UP TO \$286,372 IN OPERATING ASSISTANCE (50% OF TOTAL PROJECT COST OF \$572,744); AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY BUDGET TRANSFERS AND DOCUMENTS, UPON THE CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 25-138, the City Commission authorized certain City staff to apply for grant funding and to execute and submit grant documentation through the Federal Transit Administration (FTA) and Florida Department of Transportation (FDOT); and

WHEREAS, the Florida Department of Transportation (FDOT) is administering State Transit Block Grant funding to support cost effective, efficient, and safe transportation systems; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" (PTGA #G3F98/FM #436702-7-84-01) for State Transit Block Grant funds for transit bus route services for SFY 2026 between FDOT and the City is hereby approved in an amount of up to \$286,372.00 (50% of total project cost of \$572,744.00).

Section 2: That the City Manager is authorized to effectuate any necessary budget transfers in accordance with such grant, and to execute any necessary documents.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
