A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING PURSUANT TO SECTION 2-797(3) THE PROCUREMENT OF RESURFACING OF THREE TENNIS COURTS AT BAYVIEW PARK IN AN AMOUNT NOT TO EXCEED \$62,500.00, FROM PREMIER SURFACE SOLUTIONS, INC. THROUGH THE SOURCEWELL COOPERATIVE PURCHASING CONTRACT #060518-AST, CITY OF KEY WEST MEMBER NUMBER 58115; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, section 2-797(3) of the Code of Ordinances authorizes purchases pursuant to government contract; and

WHEREAS, City staff recommends procurement of a tennis court resurfacing at Bayview Park through the Sourcewell Cooperative Purchasing Contract #060518-AST; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the procurement of three tennis courts resurfacing, in an amount not to exceed \$62,500.00, from Premier Surface Solutions, Inc. is hereby approved, through Sourcewell

competitive bid contract #060518-AST, City Member Number 58115, pursuant to Section 2-797(3) of the Code of Ordinances.

Section 2: That funds for this purchase are budgeted in FY 22-23 in Infrastructure Surtax/Parks and Recreation/Infrastructure Account 101-7201-572-6300. Any related budget adjustments and transfers are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents associated with this purchase, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage, adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
