A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AUTHORIZING AN INCREASE IN THE TOTAL ALLOWABLE CUMULATIVE EXPENDITURES FOR FY 24-25 FOR TEN-8 FIRE AND SAFETY, ACCOUNT NO. 001-2201-5224600, FROM \$90,000.00 TO AN AMOUNT NOT TO EXCEED \$190,000.00 FOR PARTS AND EMERGENCY REPAIRS AND SERVICES TO FIRE RESCUE VEHICLES, ESTABLISHED AS SET FORTH IN EXHIBIT A. TO RESOLUTION NO. 24-244 AND PURSUANT TO §2-797, EXEMPTIONS, CODE OF ORDINANCES, CITY OF KEY WEST, FLORIDA; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS OR TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 2-796 of the Code of Ordinances, City of Key West, Florida requires competitive bidding for purchases or services in excess of \$50,000.00; and

WHEREAS, the City Commission approved *Resolution No. 24-244* on October 10, 2024 which authorized purchase exemptions for several sole source and/or blanket purchase orders for cumulative expenditures in excess of \$50,000.00 as set forth in *Exhibit A.* to *Resolution No. 24-244*, which includes Ten-8 Fire and Safety in the amount of \$90,000.00; and

WHEREAS, Ten-8 Fire and Safety provides essential repairs and equipment for Fire Rescue apparatus; and

WHEREAS, to date, the Fire Department has exceeded the \$90,000.00 budgeted in Account No. 001-2201-5224600 for parts and emergency repairs for Fire Rescue vehicles and, based on trends and equipment

evaluations, additional funding in an amount up to \$100,000.00 is necessary; and

WHEREAS, the City Manager finds it is *in the* best interest of the City to increase the amount of allowable expenditures for Ten-8 Fire and Safety for parts and repairs and service to Fire Rescue vehicles to \$190,000.00 during FY 24-25, pursuant to Sec. 2-797(1)c, (2), (3)c and (4)b, Code of Ordinances, City of Key West, Florida;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1. The Commission hereby authorizes an increase of \$100,000.00 to Account 001-2201-5224600, bringing the total funds available in this account to \$190,000.00, for parts and emergency repairs to Fire Rescue vehicles by Ten-8 Fire and Safety, pursuant to Sections 2-797 (1)c, (3)c and (4)b, Code of Ordinances, City of Key West, Florida.

Section 2. That funds are budgeted in Account No. 001-2201-522-4600. Any necessary budget transfers and adjustments to fund the increase are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
