A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED "PUBLIC TRANSPORTATION GRANT AGREEMENT" (PTGA) #G2X63, AMENDMENT 2 BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) AND THE CITY OF KEY WEST FOR SFY2024 FTA SECTION 5311 FORMULA GRANTS FOR RURAL OPERATIONS GRANT TO EXTEND GRANT TERM AND NOT TO EXCEED \$1,600,000.00 OR THE REMAINING BALANCE OF \$1,163,979.39; AUTHORIZING THE CITY MANAGER TO EXECUTE NECESSARY DOCUMENTS AND NECESSARY BUDGET AMENDMENTS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in Resolution 24-131, the City Commission approved to PTGA #G2X63 for Section 5311 Formula Rural Operation funds for the bus route services for SFY2024;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the attached "Public Transportation Grant Agreement" PTGA #G2X63, Amendment 2 is hereby approved, between FDOT and the City, for Section 5311 Formula Rural Operation funds to extend the expiration date to June 30, 2026 and not to exceed \$1,600,000.00 or \$1,163,679.39 of the remaining balance.

Section 2: That the City Manager is further authorized to execute any and all other documents, including amendments, renewals, and extensions, subject to all

allocations, and appropriations in accordance with such grant.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
