A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF TWO (2) 2022 FORD F-250 TON PICKUP TRUCKS (\$48,025.53 EACH/\$96,051.06 TOTAL), ONE (1) 2022 FORD F-250 TON PICKUP TRUCK (\$51,329.17) AND ONE (1) 2022 FORD EXPLORER (\$37,283.53) IN A TOTAL AMOUNT NOT TO EXCEED \$184,663.76 FROM DUVAL FORD LLC, THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA20-VEL28.0, PURSUIT, ADMINISTRATIVE AND OTHER VEHICLES CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST FIRE DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA20-VEL28.0 - Pursuit Administrative and Other Vehicles Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of Two (2) 2022 Ford F250 Pickup Truck and related accessories (\$48,025.53 each/\$96,051.06 total), One (1) 2022 Ford F250 Pickup Truck and related accessories (\$51,329.17), One (1) Ford Explorer and related accessories

(\$37,283.53), as described in the attached proposal of Duval Ford LLC, pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties Bid No. FSA20-VEL28.0 Contract, in a total amount not to exceed \$184,663.76, is hereby authorized for purchase and use by the Key West Fire Department.

Section 2: That funds for the purchase of these vehicles are budgeted in Fire Department Infrastructure Surtax Fund 101-2201-522-6400. A total of \$170,000 is budgeted in FY 22 for these vehicles. A transfer of \$14,663.76 is hereby authorized from Infrastructure Surtax Fund reserves 101-2201-522.9803 to cover the balance of vehicle's cost. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
