**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AIDS HELP, INC TO CONDUCT THE CORONATION OF THE KING & QUEEN OF FANTASY FEST AT THE SOUTHERNMOST BEACH CAFÉ ON FRIDAY, OCTOBER 21, 2011 FROM 9:00 A.M. TO 12:00 MIDNIGHT; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 6:00 P.M. TO 12:00 MIDNIGHT; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, AIDS Help, Inc. wishes to conduct the Coronation of the King & Queen of Fantasy Fest.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West, Florida;

**SECTION 1.** That AIDS Help Inc. is hereby granted permission to conduct the Coronation of King & Queen of Fantasy Fest on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater shall be donated to AIDS Help Inc.

**SECTION 2.** That AIDS Help, Inc. is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 3.** That pursuant to Section 18-86 of the Key West Code of Ordinances, AIDS Help, Inc. is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

**SECTION 4.** That AIDS Help Inc. will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

**SECTION 5.** This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
