A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING A PURCHASING EXCEPTION PURSUANT TO SECTION 2-797 OF THE CODE OF ORDINANCES, TO ALLOW AN ADDITIONAL \$71,000.00 IN CUMULATIVE EXPENDITURES DURING FY 13-14 TO CUMMINS SOUTHEASTERN FOR BUS ENGINE REPAIR, RESULTING IN A TOTAL AMOUNT NOT TO EXCEED \$106,000.00; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Section 2-796 of the Code of Ordinances requires competitive bidding for purchases or services in excess of \$20,000.00; and

WHEREAS, Cummins Southeastern is a sole-source provider for bus engine repair for the Key West Department of Transportation; and

WHEREAS, in Resolution No. 13-302 the City Commission approved a purchasing exception for cumulative expenditures not to exceed \$35,000.00; and

WHEREAS, as certain City buses age, the failure of essential components has increased, and funding of \$71,000.00 in addition to the initially approved \$35,000.00 is necessary; and

WHEREAS, the City Manager finds that pursuant to section 2-797(4), it is in the best interest of the City to authorize an increased expenditure for services rendered by Cummins Southeastern this fiscal year.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the expenditure of funds in an amount not to exceed \$106,000.00, (\$71,000.00 of new funding in addition to the \$35,000.00 already approved) to Cummins Southeastern is hereby authorized in accordance with Key West City Code of Ordinances section 2-797(4)(b).

Section 2: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
