Diameter: 8.2"

Location: 60% (growing in back yard, corner lot-visible from street, canopy growth impacted by adjacent mango tree)

Species: 100% (on protected tree list)

Condition: 60% (overall condition is fair, growth lean, lopsided canopy)

Total Average Value = 73%

Value x Diameter = 5.9 replacement caliper inches

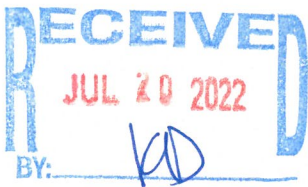

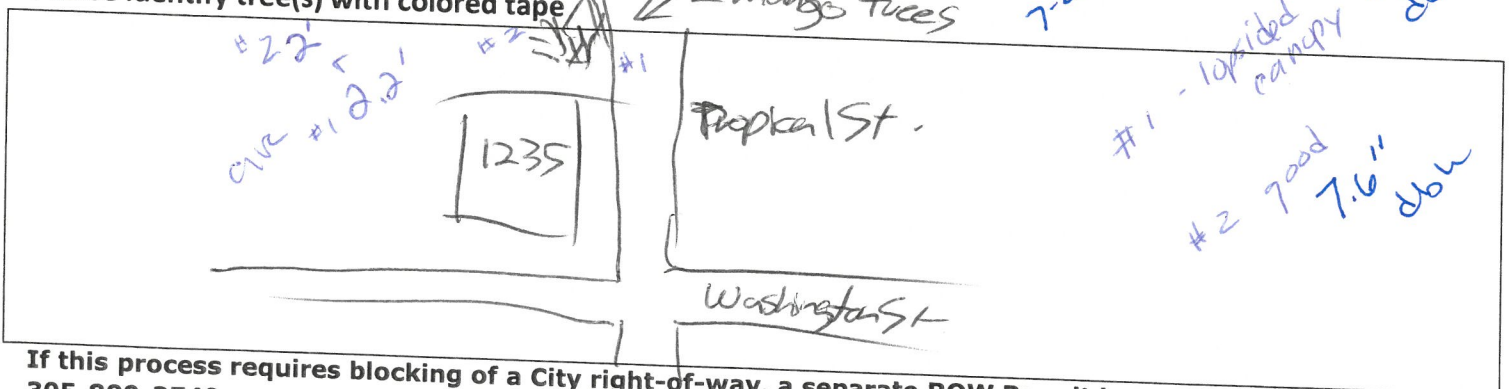
