-- Andres Camilo Forero Ortiz Arrest Narrative:

On 05/21/2023 at approximately 1126 hours, I was dispatched to Sigsbee Navy base for a battery call.

When I arrived Ofc. Tellier and Ofc. K. Hansell were on scene and talking to the witnesses Jennifer Wilson and Amanda Grimes. Ofc. Howell and Ofc. Litton were searching the base for the suspect vehicle a Hyundai Elantra (CA tag 9DOP273). Grimes had taken a picture of the suspect and sent it to Ofc. K. Hansell. Ofc. K Hansell sent the picture to all officer on the shift to be able to identify the suspect.

I spoke with Wilson. Wilson was driving her vehicle south of Sigsbee Rd she witnessed three female walking on Sigsbee Rd. toward south toward N. Roosevelt Blvd. She then witnessed the above vehicle approach the females at a high rate of speed and cut them off. A male later identified as Andres Forero Ortiz, get out of the vehicle and punch one of the females later identified as Sandra Ramos Ortiz (Andres Ortiz's fiancé) in the face. The female was later identified as Sandra Ramos Ortiz in the face. She then stopped her vehicle. By the time she stopped the Andres was shoving the children into the vehicle. The children were later identified and Andres and Sandra's daughters Lesly Forigua Ortiz and Johelin Ramos Ortiz.

Grimes gave a sworn witness statement stating she witnessed Andres throw Sandra to the ground.

By this time Ofc Howell had located the suspect vehicle at 1079 Farragut Rd. unit A. I then left for that address to back up Ofc. Howell. I arrived at the same time as Ofc. K Hansell. Ofc. Howell, Ofc. Litton were already on scene and speaking to the occupants through partition to the back patio. I noticed there was a backdoor to the patio. Ofc. Litton and I then began walking around the back of the house to the back door. When we got to the backdoor the male suspect had entered the house through a door on the patio. Ofc. Howell had also entered the house through the front door. Ofc. Howell had Andres by the right arm and was giving the male verbal commands to stop. I made the decision to detain Andres as he was the suspect in the battery. I then grabbed Andres's left arm and placed it behind his back. He then began to pull away and resist our attempts to place his hands behind his back. Andres was then taken down on the sofa in the house by Ofc. Litton, Ofc. Howell and I. Andres continued to resist. I attempted to gain control of Andres's legs as he continued to resist. Ofc. Howell, Ofc. Litton and Ofc. K Hansell were attempting to gain control of Andres's upper body. As he continued to fight Ofc. Litton drive stunned Andres in attempt to gain compliance. For further information please see Ofc. Howell, Ofc. Litton and Ofc. K. Hansell's supplemental reports. By this time Sgt. Conaty had arrived to assist. We were able to Get Andres off the sofa and onto the floor to be able to make another attempt to handcuff Andres. Once he was on the floor he continued to resist. Sgt Conaty then drive stunned Andres in the upper torso for further information please see Sgt. Conaty's supplemental report. We were able to gain control of Andres's arm and handcuff him. Ofc. Howell then retrieved a hobble and applied it to Andres's legs to prevent him from kicking anyone. He was then placed onto his left side into the recovery position. KWFR was then requested to come and assess Andres for any injuries.

Once the altercation was over it was able to speak with all officers involved and it was determined that Ofc. K. Hansell, Ofc. Litton, and Ofc. Howell had been battered by Andres during the altercation. Ofc. K Hansell was struck in the chest and the top of her head. Ofc. Litton was struck in the left eye. And Ofc. Howell was elbowed in the chest, kicked in the chest and legs.

KWFR and NAS Fire Rescue arrived and assessed Andres. It was determined it was best to transport Andres to LKMC for clearance. MCFR transported Andres to LKMC (run number MCFD23OSS002095).

On Sunday, 05/21/2023 at approximately 1126 hours; I (Ofc. Howell) was dispatched to assist other officers near Sigsbee Road, leading into Sigsbee Navy Base, regarding an unknown Hispanic male subject possibly involved in a domestic argument with his significant other.

As I arrived on scene, Ofc. Tellier and Ofc. Litton were speaking with several witnesses. I was not involved in their interviews. Ofc. Litton informed me that one of the witnesses provided a picture of the potential suspect and provided a detailed description of the possible domestic incident, to include a description of the unknown Hispanic male subject and the vehicle he was driving. Ofc. Litton informed me that the vehicle was a black or dark gray Hyundai Elantra that had California tags: 9DOP273.

I discovered a vehicle matching the description provided, with corresponding tags, parked within the driveway at the residence: 1079-A Farragut Road. At this point, I flagged down a Navy Police Officer and notified him that I discovered the vehicle. The Navy Police Officer and I entered the driveway and discovered the potential suspect and his family sitting within an enclosed patio near the rear to the garage. There was no entrance to the rear patio from the front of the garage. The only two entrances to the rear patio are an interior doorway from the living room area and an exterior doorway from the back yard. I instructed the unknown Hispanic male subject to remain where he was. The unknown Hispanic male subject, and his family, continuous yelled that they did not speak English in Spanish. At this point, Ofc. Litton, Ofc. K. Hansell, and Ofc. Roscoe arrived on scene. Ofc. Roscoe and Ofc. Litton began walking around the residence to attempt to enter the rear patio from the back yard. As Ofc. Roscoe and Ofc. Litton began walking around, the unknown Hispanic male subject immediately ran to the doorway leading into the living room area. I clearly and concisely instructed the unknown Hispanic male to stop and turn around. The unknown Hispanic male ignored me and continued to run inside the residence. Have no knowledge of potential weapons or other individuals that may be inside the house, I kicked in the front doorway. Ofc. K. Hansell followed me inside. I immediately discovered the unknown Hispanic male subject attempting to grab for an object under the cushions within the living room couch. I immediately grabbed the unknown male subjects left hand and pulled him away from the living room couch. At this point, Ofc. Roscoe and Ofc. Litton mad entry through the rear doorway, from the back yard. Ofc. Roscoe immediately grabbed the unknown Hispanic male subject's right hand. Ofc. Roscoe and I attempted to place the unknown Hispanic male suspect in handcuffs. The unknown Hispanic male suspect pulled away from Ofc. Roscoe and me, tensed up, balled his fists, and struck Ofc. Roscoe and me with closed fists. The unknown Hispanic male subject continuously refused to comply with our lawful, legal orders. Due to the unknown Hispanic male's aggressive actions, continuous hostility, and level of resistance rising Ofc. Litton performed a controlled takedown, and we placed the unknown Hispanic male subject on the living room couch, facedown. The unknow Hispanic male subject continued to attempt to roll over to face Ofc. Litton, Ofc. Hansell and me. The unknown Hispanic male subject continued to punch with closed fists, kick, and attempted to bite Ofc. K. Hansell, Ofc. Litton, Ofc. Roscoe, and me. At this point, Sgt. Conaty arrived on scene. The unknown Hispanic male subject continued to struggle, refusing to be

handcuffed until we rolled him onto his stomach on the living room floor with the assistance of Sgt. Conaty. Due to the unknown Hispanic male's aggressive actions, continuous hostility, and level of resistance rising Sgt. Conaty and Ofc. Litton drive stunned the unknown Hispanic male subject at different times throughout the ensuing physical altercation. Reference their supplemental reports for further details. Due to the unknown Hispanic male's aggressive actions, continuous hostility, and level of resistance rising Ofc. Roscoe and I placed the unknown Hispanic male subject in a hobble to prevent further kicking. The unknown Hispanic male subject did not appear to have any injuries as a result of his struggling and the physical altercation.

It is important to note that throughout this physical altercation, all officers on scene were involved at differing times in separating the unknown Hispanic male subject family members, to include his children, from the altercation.

It is important to note that a pocketknife with an approximately five-inch blade was later discovered directly under the seat cushion of the living room couch where the unknown Hispanic male subject was attempting to grab an object before the physical altercation ensued.

Ofc. K. Hansell and I placed the unknown Hispanic male subject in the recovery position and maintained control of the unknow Hispanic male while Sgt. Conaty, Ofc. Litton, and Ofc. Roscoe searched the residence and removed other family members from the house. Key West Fire/Rescue, Rescue 3, and Monroe County Fire/Rescue, Rescue 8, responded to the residence and cleared he unknown Hispanic male medically, reference Key West Fire/Rescue Run Number: 23-2773 and Monroe County Fire/Rescue Run Number: MCFD23OSS002095 for further details. Due to the nature of the physical altercation, we decided to have Monroe County Fire/Rescue transport the unknown Hispanic male subject to Lower Key Medical Center for further evaluation. Ofc. K. Hansell and I walked the unknown Hispanic male subject to Recuse 8. I rode in the ambulance to Lower Keys Medical Center to prevent further aggressive and hostile actions, while Ofc. K. Hansell followed in her patrol vehicle. Ofc. K. Hansell and I searched the unknown Hispanic male subsequent to arrest.

While at Lower Keys Medical Center, the unknown Hispanic male subject was evaluated and medically cleared by the emergency room staff and Dr. Schultz.

Ofc. Hansell and I transported the unknown Hispanic male subject to Monroe County Detention Center, without further incident.

It was later discovered that the unknown Hispanic male subject's name is Andres Camilo Forero Ortiz (05/25/1997, Arrestee) and he had previous law enforcement encounters/arrests with Key West Police Department officers.

On 05/21/2023 at approximately 1130 hours, I (Ofc. A. Litton) was dispatched to Sigsbee Navy Base in reference to a battery investigation.

When I arrived, I obtained a description of the suspect and his vehicle and attempted to locate them on the base. Officer W. Howell located the vehicle at 1079-A Farragut Road along with a positive identification of the suspect and family. Officer W. Howell was attempting to speak with the suspect, Andres Forero Ortiz, through a screen wall. Officer R. Roscoe and I walked to the back of the property where we saw a screen door was located to the enclosure. As we were walking around the building, Ortiz fled inside the residence and Officer W. Howell followed through the front door. Officer R. Roscoe and I followed Ortiz through the back door as Howell was attempting to place him in handcuffs.

Ortiz began to resist Officer W. Howell and Officer R. Roscoe as they attempted to place him in handcuffs. Ortiz pulled away from Officer R. Roscoe when I grabbed Ortiz's left arm to keep him from running out the back door. Ortiz fell onto the couch and continued to resist, kicking and punching every chance he could. At one time during the scuffle, Andres managed to free one hand and struck me with a closed fist in my left eye. I drew my duty issued Taser and delivered a drive-stun to Ortiz's right ribcage to attempt to gain pain compliance. The drive-stun proved ineffective, so I holstered the Taser and eventually placed handcuffs on Ortiz with the additional help of Sergeant J. Conaty.

This concludes my involvement in this case.

On 5/21/2023 at approximately 1126 hours I, Officer K. Hansell heard officers being dispatched to a battery at the intersection of Sigsbee Rd and N. Roosevelt Blvd. I left the station and drove outbound on N. Roosevelt Blvd until dispatch stated the vehicle invovled had returned onto Sigsbee Base.

I drove to Sigsbee Base where I met with the officers on scene. The witnesses were being interviewed. I did speak to a white female who stated that she had observed a male drive at a high rate of speed down Sigsbee Rd, make contact with a female and two female juveniles near the corner of Sigsbee Rd and N. Roosevelt by the unmanned guard shack. The female stated the male "punched" the adult female and "threw" her back into the vehicle. The witness stated that the male also "threw" the juveniles into the vehicle and then U-turned, heading back onto Sigsbee Base. The witness did not know where the vehicle went on base. Another female witness provided a photo of the male suspect and a photo of the vehicle/license plate he had been driving.

I sent the photos to Officer Howell who was looking for the vehicle on base. As I stood-by I heard Officer Howell state he had located the suspect vehicle in the drive way of 1079A Farragut Rd. I asked the witnesses to stand-by with Officer Tellier and drove to the address. Officer Howell and LItten were already on scene. The male suspect, a hispanic female in a black sundress, and two juvenile females were standing on the porch. We attempted to speak to the male who walked away from police as we did so. The male walked into the residence which took him out of our view. It should be noted that all officers were in "Class B" uniforms and arrived on scene in marked police cruisers. It should also be noted that the male standing on the porch matched the photo provided by the witnesses on scene.

For Officer Safety Officer Howell opened the front door to the residence. The male suspect walked toward the couch. I stepped inside the residence behind Officer Howell as Officer Howell began to give verbal commands to the male to stop reaching and put his hands behind his back. The male immediately pulled away from Officer Howell. At this point, Officer Roscoe and LItten had entered the residence from the rear door as they had walked around the residence to attempt to speak to the male suspect and the females on the porch.

The suspect immediatley began pulling away physically from Officer Howell and Officer Roscoe. I stepped around Officer Howell, Roscoe and the suspect and gave immediate instructions to the females to step back. The adult female in the black sundress continued to move toward the suspect and officers. I physically moved her back and also had to escort one of the juveniles away also multiple times. The suspect was now physically punching and kicking Officers Howell, Roscoe, and Litten as they transported him down on to the couch. The females continued to try to move toward the suspect but I was able to move them back. An NAS member came in to the house and I instructed him to remove all three females physically from the residence. The NAS member was able to escort the females outside the residence via the front door. I called for more units due to the suspect still physically resisting.

I was able to move into a position where I had my knee on the suspects hip area and was able to get hold of his right arm. The suspect continued to punch and kick all officers multiple times. A taser was used in drove-stun mode to stop the suspect from physically resisting. I did not see who drive-stunned the suspect. The suspect was roled onto the floor and his hands were positioned in the small of his back after multiple drive-stuns. The handcuffs were placed on the suspect per KWPD policy and a hobble was positioned around his ankles to prevent him from kicking anyone.

Medical staff was requested and arrived on scene. The suspect was transported to Lower Keys Medical Center via Monroe County Rescue 8. Officer Howell rode with the suspect in the ambulance and I followed the rescue unit to the hospital.

The suspect was medically cleared and transported by Officer Roscoe to Monroe County Detention center. Officer Howell and I followed Officer Roscoe to the detention center in my marked patrol vehicle and assisted with transporting the suspect to the booking area. We stood-by until the suspect was medically cleared and jail staff took custody of the suspect.

My BWC was activated and downloaded for review. The two photos provided to me by the witness were downloaded for review.

Ortiz stated Forero placed her suitcase inside the vehicle. Ortiz stated she voluntarily went inside the vehicle and Forero apologized for suggesting that she needed surgery. Ortiz stated the police officers then arrived on scene.

Ortiz stated Forero never struck her and that it was only a verbal argument. I gave Ortiz a Victim Right's Brochure with a case number. This incident was recorded on my BWC.

The caller Jennifer Wilson (FL DL) stated a Hispanic male punched a woman and pushed her into a car, and pushed her two small daughters into the car. She stated they drove back into the housing area.

Upon my arrival, I met with Wilson who was waiting on the causeway. She stated she was driving South on the causeway when a black Hyundai passed her. She stated the car was speeding. She stated the car stopped abruptly in front of a woman and two small girls. The woman and the two girls were on the oposite side of the road. She stated the Hispanic male driver got out of the car and hit the woman in the head. She stated he then forced her into the car, and forced the two small girls into the car. She stated the male made a U-turn and headed back into the housing area.

Dispatch provided a California license plate for the vehicle. I was speaking with Wilson while other officers canvassed the base looking for the car. Ofc. Howell located the car parked at 1079 Farogut Rd Unit A. Officers responded to that location. I stayed on the causeway getting written statements from two different witnesses.

While I was getting statements, I heard another officer say "He's fighting us". I left the causeway and responded to that location.

Upon my arrival, Ofc. K. Hansell, Ofc. N. Howell, Ofc. A. Litton, Ofc. R. Roscoe, had Andres Ferero Ortiz hancuffed after he fought them.

Since Ferero Ortiz was secured I gathered information for Ofc. R. Roscoe's domestic violence investigation. I was able to obtain all the involved parties information for Ofc. R. Roscoe.

After Ferero Ortiz was transported to the hospital, I remained on scene until Ofc. V. Arguello responded to translate for the female half. I drove out to the hospital to assist Ofc. K. Hansell and Ofc. N. Howell with Ferero Ortiz's medical clearance.

On May 21, 2023 at approximately 1150 hours, I (Detective Sergeant Jay Conaty) was working an off-duty detail at Ibis Bay Resort (3101 N. Roosevelt Blvd.) I heard a call on the radio from Ofc. K. Hansell that the units on scene at 1079A Farragut Road needed an additional unit.

Due to my close proximity to Sigsbee Naval Park, I activated my emergency lights and sirens and drove to 1079A Farragut Road. When I arrived, I was directed into the living room of the residence by a Navy Police Officer.

I saw a Hispanic male (later identified as Andres Forero, DOB 05/25/1997) wearing a blue shirt actively resisting the officers (Officer. K. Hansell, Officer. W. Howell, Ofc. C. Roscoe and Ofc. A. Litton) on scene that were attempting to get him into custody. I attempted to assist the officers getting Forero from the couch and onto the floor to place him in handcuffs.

While Forero was on the floor, he still actively resisted by not giving his hands and trying to escape our control. I pulled out my Taser and used the drive-stun mode on his left shoulder and then his back right shoulder blade until he complied with orders to give us his hands. I used the drive-stun mode for about 4 cycles. Officer Hansell was then able to place him in handcuffs.

Officer Hansell placed Forero into the recovery position. I asked Communications Channel 1 to send Rescue to evaluate Forero. Forero did not appear to be injured but did appear highly intoxicated.

Sergeant Sims arrived on scene, and I briefed him on what I did and what I witnessed. I then returned to my off-duty detail.
