-- Trey Jacob Dulaney Arrest Narrative:

On Thursday, March 21, 2024, at approximately 0034 hours, I (Officer James Young) was dispatched to 202 Duval Street (Rick's Bar) in reference to a trespasser.

Upon arrival, Officer Thornbrugh, and I, met with the security of Rick's and he walked us to the back office. We met with the on-duty manager reviewing the video footage of the male who wouldn't leave Rick's Bar. The manager just wanted to give the male a trespass warning for the bar. We left the office and noticed the same male from the video footage across the street attempting to get inside Sloppy Joe's.

Security from Sloppy Joe's wouldn't let the male inside for being too intoxicated. Officer Thornbrugh and I contacted the male and was able to identify him, from his Kansas Driver's license, Trey Jacob Dulaney.

Officer Thornbrugh and I issued Trey a trespass warning for Rick's Bar, Trey understood if he goes back into Rick's property he would be arrested. I advised Trey to go home. Trey would continue to get close to me, while I had reminded him to not get close to me or touch me. Trey would repeatedly ask the questions "What's going on?" I told him to go home. Officer Thornbrugh and I walked back across the street.

We noticed that Trey continued to try to enter Sloppy Joe's Bar and that security would push him out of the bar entrance. Trey then pulled his shorts down enough to grab his penis and actively masturbate towards the security employees. Trey's shorts were down far enough where you could visibly see his penis by anyone in eyesight of Trey. Officer Thornbrugh and I walked back over to Sloppy Joe's Bar. The security just wanted the male to leave.

A male was inside Sloppy Joe's who saw Trey masturbate, told Officer Thornbrugh he was shocked and wanted to pursue charges against him, for the act of masturbating with his sexual organs exposed for everyone to see in the bar and the surrounding area on Duval Street. The victim's name was Jamie Lyle Popp, and wanted Trey to be arrested for the act. Jamie received a Victim Rights Brochure.

I placed Trey in handcuffs and double locked them at the entrance of Sloppy Joe's Bar. Officer Thornbrugh and I escorted him back to my patrol vehicle on Charles St. While on Charles St. Trey was pulling away from us when we were near the patrol vehicle. Officer Thornbrugh told me to get my vehicle in the road so we could place him into my vehicle passenger side back seat. Trey leaned towards Officer Thornbrugh. Officer Thornbrugh told him he was going into my patrol vehicle. Trey then lunged towards me and with his right leg tried to kick towards my face. I blocked the incoming kick with my left arm and was only struck on the left shoulder area instead of my face. Officer Thornbrugh maintained control of Trey's right arm during this time, and as a result of kicking me, redirected him to the ground in a controlled manner.

At the time of this encounter, I was wearing a Key West Police Class B uniform, clearly identifiable with the agency insignia. Trey knowingly and willfully struck me against my will while on duty performing my lawful duties.

Upon my investigation, Trey Jacob Dulaney committed the offense of Unlawful exposure of sexual organs FS 800.03. Trey Jacob was naked in a vulgar and an indecent manner in front a crowded bar on Duval Street in front of Sloppy Joe's Entrance in which Jamie Popp was the victim of the act.

Upon my investigation, Trey Jacob Dulaney committed the offense of Battery on Leo FSS 784.07-2B. Trey kicked a law enforcement officer wearing his on-duty uniform on the left shoulder. Trey intended to do harm to an on duty officer with a strike to the area of the officer's head with a kick from his right leg. Trey also committed the offense of resisting without violence FSS 843.02. Trey was not listening to verbal commands, pulling away from officers while placing him in the vehicle.

On 3/21/2024, at approximately 0015 hours, I Officer Thornbrugh alongside Officer J. Young responded to 202 Duval St, (Rick's) for a disorderly patron.

Upon arrival I met with the Manager of Rick's, Curtis. Curtis informed me a patron started to threaten him and his security and caused a disturbance inside the bar; Curtis wished to have the subject trespassed.

Ofc. J. Young and I relocated to Sloppy Joe's, where we observed the same subject talking with security. I identified the subject as Trey Dulaney by his Kansas driver's license. I informed Trey that he was being trespassed from Rick's, and if he were to return to the property, he would be subject to arrest. Trey stated that he understood.

Shortly after leaving Sloppy Joe's, Ofc. J. Young and I observed Dulaney with his penis in his hand moving his hand in a back-and-forth motion. We spoke with security and another witness who was offended by what they witnessed. Ofc. J. Young placed Dulaney into custody. Ofc. J. Young and I escorted Dulaney to Ofc. J. Young's patrol vehicle. As we were escorting Dulaney, Dulaney turned and kicked Ofc. J. Young in the arm nearly striking Ofc. J. Young in the head. I performed a modified straight arm take down, and redirected Dulaney to the ground to stop the immediate threat that he imposed to Ofc. J. Young and myself. I escorted Dulaney to Ofc. J. Young's patrol vehicle.

I spoke with Curtis again to collect video camera footage. Curtis informed me the video would not be downloaded until 3/21/2024 in the afternoon.

This is the end of my involvement with this case.
