

RESOLUTION NO. 24-041

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING CHANGE ORDER NO. 1 IN THE AMOUNT OF \$53,120.00 FOR ADDITIONAL BENTHIC SURVEY COSTS ASSOCIATED WITH A TASK ORDER ISSUED TO TETRA TECH, INC. FOR WATERFRONT FACILITIES INSPECTION AND DESIGN OF REPAIRS TO THE MOLE PIER BULKHEAD AT NAVY PORT OPS; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in lieu of rent payments to the Navy for use of the Mole Pier, the City has agreed to perform certain in-kind projects, as per the terms of Public Benefit Lease N69450-12-RP-00166 approved by Resolution 14-034; and

WHEREAS, in Resolution No. 21-268, the City Commission approved a task order for Tetra Tech, Inc. in the amount of \$140,770.00 for waterfront facilities inspection and design repairs to the mole pier bulkhead at Navy Port Ops; and

WHEREAS, additional permitting requirements have expanded the needs for benthic survey to satisfy the Army Corps of Engineers; and

WHEREAS, Tetra Tech, Inc. has provided a change order proposal to include the necessary survey and reporting to fulfill permit requirements; and

WHEREAS, Section 2-845(a) change orders exceeding five cumulative percent of the contract price, or \$50,0000.00, whichever is less, require city commission approval,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA AS FOLLOWS:

Section 1: That change order no. 1 for additional survey for the mole pier bulkhead project at Navy Port Ops is hereby approved in an amount not to exceed \$53,120.00.

Section 2: This Task Order will be paid from account 101-1900-519-9803. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager is authorized to execute any necessary documents, upon the advice and consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
