A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) CATERPILLAR EC25N ELECTRIC FORKLIFT WITH RELATED ACCESSORIES (\$53,089.00) AND ONE (1) CATERPILLAR DP30N5 DIESEL FORKLIFT WITH RELATED ACCESSORIES (\$55,860.00) IN A TOTAL AMOUNT NOT TO EXCEED \$108,949.00 FROM KELLY TRACTOR CO., THROUGH PIGGYBACKING ON THE FLORIDA SHERIFF'S ASSOCIATION AND FLORIDA ASSOCIATION OF COUNTIES BID NO. FSA23-EQU21.0, HEAVY EQUIPMENT CONTRACT, PURSUANT TO SECTION 2-797(3) OF THE CODE OF ORDINANCES FOR USE BY THE KEY WEST COMMUNITY SERVICES DEPARTMENT; AUTHORIZING NECESSARY BUDGET TRANSFERS OR ADJUSTMENTS; AUTHORIZING THE CITY MANAGER OR DESIGNEE TO EXECUTE NECESSARY DOCUMENTS, UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, this purchase will be made under the Florida Sheriffs Association and Florida Association of Counties Bid No. FSA23-EQU21.0 Contract, pursuant to section 2-797(3) of the Code of Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That the purchase of one (1) Caterpillar EC25N Electric Forklift and related accessories (\$53,089.00), and one (1) Caterpillar DP30N5 Diesel Forklift with related accessories

(\$55,860.00), as described in the attached proposals of Kelly Tractor Co., pursuant to section 2-797(3) of the Code of Ordinances, under the Florida Sheriff's Association and Florida Association of Counties FSA23-EQU21.0 Heavy Equipment Contract, in a total amount not to exceed \$108,949.00, is hereby authorized for purchase and use by the Community Services Department.

Section 2: That funds for the purchase of the diesel forklift are budgeted under General Fund/Fleet Services Management/ Machinery and Equipment Account 001-1904-519-6400, and funds for the purchase of the electric forklift are budgeted under General Fund/Public Works/Machinery and Equipment Account 001-1905-519-6400. Any necessary budget transfers or adjustments are hereby authorized.

Section 3: That the City Manager or designee is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
