## RESOLUTION NO.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE ATTACHED ART IN PUBLIC PLACES BOARD SELECTION OF THREE (3) UNIQUE PUBLIC ART WORKS FROM BILLY KEARINS (EXTERIOR MURAL), CRAIG GRAY (EXTERIOR STONE CARVING) AND SALLY BINARD (INTERIOR MURAL) FOR THE FREDERICK DOUGLASS COMMUNITY CENTER AT 111 OLIVIA STREET IN A AMOUNT NOT то EXCEED TOTAL \$80,000.00, PURSUANT TO SECTION 2-797(1) AND 2-797(4)(b) OF THE CODE OF ORDINANCES AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Art in Public Places Board (AIPP) considered at a public meeting the acquisition of unique public art works, and recommends to the City Commission the purchase of three works to be displayed at the Frederick Douglass Community Center; and

WHEREAS, the art works are available solely through the artists, and Key West Code of Ordinances section 2-797(1) permits the purchase of goods and services without competition on a sole source basis under certain specified conditions; and

WHEREAS, the City Manager additionally finds that the purchase of public art works, as described in the attached memorandum, is in the best interests of the City pursuant to section 2-797(4)(b) of the Code of Ordinances; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

<u>Section 1</u>: That the Art in Public Places Board's recommended selection for unique public art from artists Billy Kearins (exterior mural), Craig Gray (exterior stone carving) and Sally Binard (interior mural) for the Frederick Douglass Community Center, located at 111 Olivia Street, is hereby approved in the total amount of \$75,000.00, pursuant to Section 2-797(1) and 2-797(4)(b) of the Code of Ordinances and \$5,000 from the AIPP Art Community Fund for a total of \$80,000.

Section 2: That funds for these art installations will be paid from FY 24-25 Bahama Village TIF Fund for \$75,000 from Account 601-5502-555-6200 (Project BV55021701), and \$5,000 from AIPP Community Fund Account 110-5902-559-4600 for a total of \$80,000, any necessary budget transfers or adjustments are hereby authorized.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
