WHEREAS, in Resolution 24-076 the City of Key West approved the $1^{\rm st}$ Amendment to Agreement #2985, a no-cost time extension to September 30, 2025; and

WHEREAS, City staff recommends approving the attached $2^{\rm nd}$ Amendment to Agreement ID #2985, which grants a second no-cost time extension for the project; and
