A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING JUST A FEW FRIENDS, KEY WEST LLC TO CONDUCT "JUST A FEW FRIENDS, KEY WEST" AT THE TRUMAN WATERFRONT MAJOR FIELD AND A SECOND LINE WALKING PARADE HONORING JIMMY BUFFET'S LEGACY ON THE 3<sup>RD</sup> ANNIVERSARY OF HIS DEATH ON SUNDAY, SEPTEMBER 6, 2026, FROM 4:00 P.M. TO 10:00 P.M.; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF CERTAIN STREETS OR PORTIONS THEREOF FOR SAID EVENT FROM 4:00 P.M. TO 5:30 P.M.; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCE PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Just a Few Friends, Key West LLC has applied to the city for a Special Event Permit for "Just a Few Friends, Key West" on Sunday, September 6, 2026, at the Key West Truman Waterfront Park Major Field from 5:00 p.m. to 10:00 p.m. and a second line walking parade honoring Jimmy Buffet's legacy on the 3<sup>rd</sup> anniversary of his death on Duval Street from Front Street to Southard Street, from 4:00 p.m. to 5:30 p.m.; and

WHEREAS, Section 6-86 of the Key West Code of Ordinances requires a Special Event permit to depart from the requirements of the City's Noise Control Ordinance; and

WHEREAS, amplified music will be played during the event from 5:00 p.m. to 10:00 p.m.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST FLORIDA.

SECTION 1. That in Resolution 19-174, the City Commission directed the city Manager to "develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the local government for the provision of good or services, unless such use is otherwise preempted by law."

SECTION 2. "That the vendor/lessee/licensee acknowledges the City's concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor therefore commits to refrain from the use of polystyrene/plastic straws, bags, plastic utensils and "To go" packages for food or products sold on any property leased from the City."

SECTION 3. That Just a Few Friends, Key West LLC is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place at the time and place herein described; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that the organization meets the terms and conditions set forth by the City Manager.

SECTION 4. That Just a Few Friends, Key West LLC is hereby granted permission for the use of Truman Waterfront Park Major

Field.

SECTION 5. Section 6-86 of the Key West Code of Ordinances requires a Special Event Permit to depart from the requirements of the City's Noise Control Ordinance.

SECTION 6. There will be live, amplified music during the event from 5:00 p.m. to 10:00 p.m.

SECTION 7. Pursuant to Section 18-86 of the Key West Code of Ordinances, Just a Few Friends, Key West LLC is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 8. That Just a Few Friends, Key West LLC must post the required notice regarding prohibition of purchase and sale of alcoholic beverages to persons under 21 years of age. Proof of compliance with Supplement F, paragraph 3 of the application is required at least ten (10) days in advance.

SECTION 9. That Just a Few Friends, Key West LLC will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 10. That Just a Few Friends, Key West LLC acknowledges that they are responsible for payment to the Key West Police Department, the Key West Fire Department and Community Services.

SECTION 11. That this Resolution shall go into effect

immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
