A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING ISSUANCE OF TASK ORDER NO. 11 TO BLACK & VEATCH CORPORATION FOR PREPARATION OF A 20-YEAR WASTEWATER NEEDS ASSESSMENT IN AN AMOUNT NOT TO EXCEED \$56,990.00; AUTHORIZING ANY NECESSARY BUDGET ADJUSTMENTS; AUTHORIZING THE CITY MANAGER TO EXECUTE DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Florida Statutes Section 403.9301 requires municipalities that provide a wastewater management system or program to develop a 20-year needs analysis, to be delivered to the Office of Economic and Demographic Research (OEDR) by June 30, 2022; and

WHEREAS, in Resolution No. 17-207, the City Commission approved a three-year contract for General Engineering Services to Black & Veatch Corporation and in Resolution No. 20-142 the contract was extended two years; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order No. 11 to Black & Veatch Corporation for preparation of a 20-Year Wastewater Needs Assessment for the City of Key West, in an amount not to exceed \$56,990.00, is hereby approved.

Section 2: That funds for Task Order No. 11 are budgeted in account Sewer/General Administration/Professional Services 401-3501-535-3100.

Section 3: That the City Manager is authorized to execute any necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
