A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, RATIFYING AN EMERGENCY PURCHASE OF NEW SOLID TIRES FOR THE FRONT END LOADER AT THE TRANSFER STATION FROM KELLY TRACTOR, IN THE AMOUNT OF \$26,673.84, APPROVED BY THE CITY MANAGER IN EXCESS OF \$20,000.00, PURSUANT TO SECTION 2-797(2) OF CITY'S CODE OF ORDINANCES; AUTHORIZING NECESSARY BUDGET TRANSFERS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, front end loaders are critical to the successful operation of the transfer station facility, and the 2012 loader needed replacement solid tires due to extensive wear in order to remain operable; and

WHEREAS, Kelly Tractor is the only factory-authorized parts and service dealer for Caterpillar Tractors in the State of Florida; and

WHEREAS, the City Manager acted without delay, using emergency powers authorized under Section 2-797(2) of the City's Code of Ordinances, to authorize and procure new solid tires for the 2012 Front End loader to ensure ongoing efficient operation of the transfer station; and

WHEREAS, Section 2-797(2) of the City's Code of Ordinances requires the City Commission to ratify such an emergency procurement at its next scheduled meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSON OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission, in accordance with Section 2-797(2) of the City of Key West Code of Ordinances, hereby ratifies the City Manager's emergency authorization for the procurement of new solid tires for the 2012 Front End Loader in the total amount of \$26,673.84 from Kelly Tractor.

Section 2: That budget funds for this procurement were spent from line item 403-3402-534-46, under Purchase Order number 76867.

Section 3: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the clerk of the commission.
