**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING THE NAMING OF THE PRESS BOX AT GEORGE MIRA FIELD, HOME OF THE KEY WEST JUNIOR FOOTBALL LEAGUE, AS THE "WAYNE GOLDSTEIN PRESS BOX"; PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, Wayne Goldstein served the Key West Junior Football League faithfully for many years as both a coach and as the voice of the youth football league; and

WHEREAS, Mr. Goldstein made significant contributions to the development and spirit of the youth football program in the City of Key West, earning the admiration and gratitude of players, families, and the community at large; and

WHEREAS, the Key West Junior Football League and community members held a tribute in his honor following his passing in 2019 to recognize his enduring impact on local youth sports; and

WHEREAS, the Key West Junior Football League has formally requested that the press box at George Mira Field be named in honor of Mr. Wayne Goldstein; and

WHEREAS, the City Manager's Office finds this request to be appropriate and in the spirit of recognizing those who have served our community with dedication and distinction; and

WHEREAS, there is no financial impact associated with this naming;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: The City Commission hereby approves the naming of the Key West Junior Football League press box at George Mira Field as the "Wayne Goldstein Press Box."

Section 2: The City Manager is authorized to take all necessary actions to implement this resolution.

Section 3: This Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the Presiding Officer and the Clerk of the Commission.
