**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING AMERICAN CANCER SOCIETY AND THE KEY WEST SUNRISE ROTARY CLUB TO CONDUCT A “ROCKING AWAY CANCER” EVENT AT BAYVIEW PARK ON SATURDAY, APRIL 9, 2011 FROM 12:00 NOON TO 6:00 P.M, PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 6:00 P.M; AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES ON THE DATE AND DURING THE HOURS STATED ABOVE; PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS,** “Rocking Away Cancer” has pledged that 100 percent of the monies raised at this event will go towards the American Cancer Society Relay for Life.

**NOW, THEREFORE, BE IT RESOLVED** by the City Commission of the City of Key West Florida;

**SECTION 1.** That American Cancer Society and the Key West Sunrise Rotary is hereby granted permission to conduct a “Rocking Away Cancer” Event on the day and during the hours stated above; **PROVIDED** that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; and that organization meets the terms and conditions set forth by the City Manager

**SECTION 2.** That the American Cancer Society & Key West Sunrise Rotary Club will adhere to the recycling plan of the City of Key West.

**SECTION 3.** That the American Cancer Society & the Key West Sunrise Rotary Club is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

**SECTION 4.** That pursuant to Section 18-86 of the Key West Code of Ordinances, the American Cancer Society & the Key West Sunrise Rotary Club are hereby granted permission to allow the sale and consumption of alcoholic beverages.

**SECTION 5.** That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
