FLORIDA, AS FOLLOWS:


Section 1: That the naming of the access road behind City Hall

signature of the presiding officer and the Clerk of the Commission.



SUBJECT: EXECUTIVE SUMMARY, NAMING ROADWAY

BACKGROUND

Currently, the commercial property, formerly known as the Greyhound Bus Station, faces onto the City's property with an address assignment of Duval Street. Emergency services, Fire department, and Police Department only access is through the City of Key West's City Hall parking lot and roadway. To properly assign addresses to the residential and commercial property an address from the City Hall side of the parking lot should be assigned.

OPTIONS:

1. The City of Key West's City Commission name the access road behind City Hall and the parking garage in order to establish addresses along the access road.
2. Leave the situation as is and continue with inconsistent addressing of businesses and residences along this area.
