A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MULTIRACE, LLC/SOUTHERNMOST MARATHON & HALF KEY WEST TO CONDUCT A FULL AND ½ MARATHON ON FRIDAY, OCTOBER 11, 2019 FROM 9:00 AM TO 10:00 PM (REGISTRATION) & SATURDAY, OCTOBER 12, 2019 FROM 5:00 AM TO 2:00 PM; AUTHORIZING THE CLOSURE OF SIMONTON STREET FROM FRONT STREET TO LAGERHEADS INCLUDING CERTAIN STREET CLOSURES THEREOF DURING THE EVENT; GRANTING AN EXEMPTION FROM THE NOISE CONTROL ORDINANCES PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 5:00 A.M. TO 2:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, permission is hereby granted to MultiRace, LLC/Southernmost Marathon & Half to conduct a Marathon and ½ Marathon on Friday, October 11, 2019 (Registration), & Saturday, October 12, 2019 for the Marathon & Half.

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West, Florida;

SECTION 1. That in Resolution 19-174, the City Commission directed the City Manager to “develop language that restricts the use of polystyrene by individuals on public property, temporary vendors on public property, or entities engaged in a contractual relationship with the local government for the provision of good or services, unless such use is otherwise preempted by law”

SECTION 2. “That the vendor/lessee/licensee acknowledges the City’s concern about the negative environmental impact of using disposable polystyrene products, which are neither readily recyclable nor biodegradable. Vendor/Lessee/licensee/contractor

therefore commits to refrain from the use or distribution of single-use polystyrene/plastic items, including but not limited to single-use polystyrene/plastic straws, bags, plastic utensils and “to go” packages for food or products sold on any property leased from the City”

SECTION 3. That permission is hereby granted to MultiRace, LLC/Southernmost Marathon & Half to conduct a Marathon and ½ Marathon on the date and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that the organization meet the terms and conditions set forth by the City Manager.

SECTION 4. That MultiRace LLC/Southernmost Marathon & Half is hereby granted permission for the closure of certain streets throughout the city for the Marathon and Half on the date and during the hours stated above.

SECTION 5. That MultiRace, LLC/Southernmost Marathon & Half is hereby granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 6. That the Event organizers will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 7. That MultiRace LLC will NOT use paint on the City street and that they will only use a washable chalk to mark the turn around and mile points.

SECTION 8. This Resolution shall go into effect immediately upon its passage and

adoption and authentication by the signatures of the presiding officer and Clerk of the Commission.
