The aforementioned Dell hardware products are being purchased pursuant to Florida State Contract 250-040-08-01 and per City Ordinance Sec 2-797(3) - Purchases and acquisitions under contracts of federal government and the state or its political subdivisions.

# **BACKGROUND:**

The City of Key West has initiated a Technology Replacement Plan to ensure all technology at the various city locations is kept up-to-date.

The goals of the technology replacement plan are to:

- Assure that each staff member who uses computing resources in his or her position has a computer of sufficient capability to fulfill his/her responsibilities.
- Implement minimum standards for computing equipment and promote uniformity of technology levels within departments.
- Ease resource and financial planning by reducing the effort involved in departmental budgeting and planning for new computers
- Provide for the cost effective and timely purchasing and installation of new equipment while decreasing the deployment time for new equipment.

The process calls for replacements of PCs every five years. To accomplish this goal, the City has created an inventory of the computers that are to be replaced each year. The Information Technology Department has budgeted for the stated replacement computers in the FY 2011-12 budget.

The Information Technology Department has established a standard requirement for purchasing laptops and desktops.

It should be noted standard configurations were ordered directly from Florida State Contract 250-040-08-01 pricing along with State Contract pricing for almost all customization requirements. In the few cases where customization/upgrade options were not available, IT verified that prices for such options were fair and reasonable and consistent with comparable upgrades in the industry.

After establishing the minimum standards and specifications for the indicated laptop and desktop computer systems, the Information Technology Department secured pricing from other computer sources for similar baseline technology and confirmed the Dell prices extended pursuant to Florida State Contract 250-040-08-01 were as competitive or more competitive than those prices obtained from other sources.

# **FINANCIAL IMPACT:**

The FY 2011-12 City of Key West budget included an appropriation of \$ 49,900 for the purchase of 5 laptop systems and 37 desktop systems – to include a monitor, keyboard and mouse for each of the desktop systems.

Favorable State of Florida computer pricing schedules afford the City an opportunity to procure an additional 2 laptop systems and an additional 4 desktop systems. The Commission's approval to order additional computers to cover unanticipated departmental request for computer systems and to replace unforeseen equipment failures during the fiscal year is requested. Note, even with the proposed purchase of 6 additional systems, the total price for the 48 systems is still considerable less than the \$49,900 proposed for the purchase of the 42 approved systems.

# **RECOMMENDATION:**

Approve the purchase of the following Dell laptop and desktop computers from Dell Marketing L.P. at a total cost of \$44,723.19

# CONTRACT SUMMARY STC # 250-040-0-1 - PCs / Laptops / Monitors

In March 2008, DMS Division of State Purchasing created this State Term Contract (STC No. 250-040-08-1) for Windows Based (Commercial Grade) Personal Computers, Laptops and Monitors.

Most recently, we made supplemental awards (solicited via Invitations to Negotiate [ITN]) to add MAC/OS Devices as well as Ruggedized Laptops, Tablets, and Ultra-Mobile Computers to this State Term Contract. This Contract is for a three year period with all sections terminating simultaneously on Feb. 28, 2011 (unless renewed per Florida Statute).

All of the awarded vendors have provided <u>BASE</u> discounts to be applied to their current Manufacturers Web Price (MSRP) pursuant to the terms outlined in ITN #s 13-250-040-Q (Windows Based), 5-250-040-Y (Ruggedized), and 6-250-040-Y (MAC/OS Devices).

The RFQ process is not mandatory under this contract. However, customers are encouraged seek additional discounts for volume purchases. They MAY do so by initiating their own Request for Quotes ("RFQ") among the awarded manufacturers or by direct negotiations with any single awarded manufacturer.

# **CONTRACT BREAKDOWN - Awarded Vendors by Section**
