A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AUTHORIZING MCCONNELL'S IRISH PUB & GRILL CORP TO CONDUCT THE ST. PATRICK'S DAY CELEBRATION ON MARCH 17, 2015, FROM 10:00 A.M. TO 11:00 P.M; PURSUANT TO TERMS AND CONDITIONS SET FORTH BY THE CITY MANAGER; AUTHORIZING THE CLOSURE OF THE 900 BLOCK OF DUVAL STREET FROM 10:00 A.M. TO 11:00 P.M; GRANTING A SPECIAL EVENT PERMIT PURSUANT TO SECTION 6-86 OF THE CODE OF ORDINANCES FROM 12:00 NOON TO 11:00 P.M. AUTHORIZING THE SALE AND CONSUMPTION OF ALCOHOLIC BEVERAGES WITHIN THE ENCLOSED AREA; PROVIDING FOR AN EFFECTIVE DATE

NOW, THEREFORE, BE IT RESOLVED by the City Commission of the City of Key West Florida;

SECTION 1. That McConnells Irish Pub & Grill is hereby granted permission to conduct St. Patrick's Day Celebration on the day and during the hours stated above; PROVIDED that all trash is adequately collected and contained; that a guarantee indemnifying the city is executed; that organization meet the terms and conditions set forth by the City Manager; and that 25% of gross revenue or \$1,000.00, whichever is greater, shall be donated to the Shriners/Masons.

SECTION 2. That McConnells Irish Pub & Grill is hereby granted permission for the closure of the 900 block of Duval street on the date and during the hours stated above.

SECTION 3. That McConnells Irish Pub & Grill is granted a Special Event Permit under Section 6-86 of the Key West Code of Ordinances for an event that will take place and time herein described.

SECTION 4. That pursuant to Section 18-86 (b) of the Key West Code of Ordinances, McCollums Irish Pub & Grill is hereby granted permission allowing the sale and consumption of alcoholic beverages within the enclosed area.

SECTION 5. That McCollums Irish Pub & Grill will adhere to the recycling plan of the City of Key West, that one (1) recycling container for every one (1) trash barrels will be used and that they will be placed side by side.

SECTION 6. That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signatures of the presiding officer and the Clerk of the Commission.
