A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, APPROVING TASK ORDER 13, PHASE II, UNDER THE CITY'S ENVIRONMENTAL ENGINEERING SERVICES CONTRACT WITH ATKINS NORTH AMERICA, INC. (ATKINS) IN A TOTAL AMOUNT NOT TO EXCEED \$65,158.00, FOR FINAL DESIGN AND PERMITTING FOR THE SOUTH BEACH NOURISHMENT PROJECT; AUTHORIZING ANY NECESSARY BUDGET TRANSFERS; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY NECESSARY DOCUMENTS UPON CONSENT OF THE CITY ATTORNEY; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, in Resolution No. 14-259, the City Commission approved a three-year Environmental Engineering Services contract with Atkins, and in Resolution 17-299 the Contract was extended; and

WHEREAS, South Beach, located at the south end of Duval Street, has experienced severe loss of sand and a receding shoreline, and extensive design and permitting work is necessary to effectively nourish the beach; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KEY WEST, FLORIDA, AS FOLLOWS:

Section 1: That Task Order 13, Phase II, for Final Design and Permitting, for the South Beach Nourishment project, under the City's Environmental Engineering Services Contract with Atkins North America, Inc. is hereby approved in an amount not to exceed \$65,158.00.

Section 2: This project is funded from account No. 103-1900-519-4600, South Beach Nourishment (Project FT19001802). Any necessary budget transfers are authorized.

Section 3: That the City Manager is authorized to execute necessary documents, upon consent of the City Attorney.

Section 4: That this Resolution shall go into effect immediately upon its passage and adoption and authentication by the signature of the presiding officer and the Clerk of the Commission.
